M I N U T E S

PRESENT:

Mr. Poore called the meeting to order and Councilman David L. Hooper gave the invocation.

On the motion of Mr. Kinley, seconded by Mr. Hooper, Council voted unanimously to approve the minutes from the June 1, 1982 meeting as mailed.

Mr. David Hooper presented Resolution #153 asking School District #5 Trustees to reconsider their action concerning McDuffie High School as a vocational school. On the motion of Mr. Kinley, seconded by Mr. Rhodes, Council voted 3 in favor - 2 abstained. Mr. Bratcher and Mr. Wright abstained.

Mr. Rhodes presented Resolution #154 for Council's approval asking that North Anderson School remain open and the Trustees of School District Five to reconsider their action on closing it down. On the motion of Mr. Rhodes, seconded by Mr. Kinley, Council voted three in favor and two abstentions. Mr. Wright and Mr. Bratcher abstained.

Mr. Aubrey Carver representing the concerned citizens of Powdersville, asked Council to fund \$2500 for a sewer study. On the motion of Mr. Hooper, seconded by Mr. Kinley, Council voted unanimously to include the \$2500 in the Planning and Development Board's budget for the study as requested.

Mr. Watson presented sealed bids for asphalt to be picked up at plant between July 1 and September 30, 1982. He stated that Pickens & Tribble Construction Companies bid \$24.50 per ton. On the motion of Mr. Hooper, seconded by Mr. Bratcher, Council voted unanimously to split the business as done in the past. On the motion of Mr. Rhodes, seconded by Mr. Hooper, Council voted 5-0 to approve Ordinance #85 on first reading. Mr. Bill Gaston, Chairman of the Election Commission, presented a revised budget request for the Election Commission. The Supervisor's recommended amount was \$15,998, his revised amount was \$21,487. Council discussed briefly and received as information.

Mr. Poore read a letter from the County Assessor, Dan Guffey, requesting that the County reopen the deadline to file for lower property assessments. On the motion of Mr. Wright, seconded by Mr. Hooper, Council voted unanimously to extend the date one month from June 15 until July 15, 1982.

Mr. Poore read Council a letter from the Anderson County Solid Waste Authority asking that Mr. Eugene W. Merritt, Jr. be reappointed to the board whose term will expire on June 30, 1982. On the motion of Mr. Hooper, seconded by Mr. RHodes, Council voted unanimously to reappoint Mr. Merritt.

On the motion of Mr. Kinley, seconded by Mr. Rhodes, Council voted unanimously to have second reading of the 1982-83 fy budget on June 23, 1982 at 7 p.m. in the Anderson County Courthouse.

On the motion of Mr. Hooper, Council adjourned at 7:45 p.m.
