As a member of the National School Boards Association, SCSBA supports the four major roles envisioned for all of the nation's 15,000 school boards: vision, basic structure, accountability and advocacy. Services include a year-round training program known as the Boardmanship Institute, legislative advocacy, publications, policy services, superintendent searches and a variety of on-site customized services for school boards. Some 613 school board

members serve as trustees for school districts in the state.
