Just tried to call you. I'm not sure I understand what you are asking.

Of the recommendations sent to the DHEC board by the stakeholders committee, all those that the board approved and the Gov. approved are incorporated either in the reform bill or in the proposed regulations from DHEC.

There were other suggestions from the stakeholder group, but the board asked that we prioritize and take the recommendations with the greatest amount of reform and concentrate on those. Those priority items were then given to the governor in a meeting I had with her and she chose the ones she agreed with. The other suggestions-some of which we talked about on the phone-were not taken up by either the board or the governor.
