The Department of Labor (DOL) announced the [Final Rule on Companionship Exemption](#) on **September 17, 2013**. The Rule will take effect on **January 1, 2015**.

On **September 18, 2013**, NASUAD, National Association of Medicaid Directors (NAMD) and National Association of State Directors of Developmental Disabilities Services (NASDDDS) released a joint statement at a DOL briefing on the Final Rule.

Present at the briefing were senior leadership from Department of Labor (DOL), Centers for Medicare and Medicaid Services (CMS), and Administration for Community Living (ACL). DOL leadership presented on the Final Rule and solicited early comments from the three organizations. NASUAD, NAMD and NASDDDS remain concerned that the rule could have significant unintended consequences to Home and Community Based Services. Over the next several weeks, NASUAD will be sharing additional information about DOL webinars, forums, and tools for states to use as they begin to think about implementing this new rule.

CMS Releases Basic Health Program Proposed Rule

On **September 20, 2013**, CMS issued a proposed rule establishing the standards for the Basic Health Program (CMS-2380-P) which provides states the option to establish a health

benefits coverage program for low-income individuals who would otherwise be eligible to purchase coverage through the Health Insurance Marketplace. This proposed rule sets forth a framework for Basic Health Program eligibility and enrollment, benefits, delivery of health care services, transfer of funds to participating states, state administration and federal oversight.

Public comments on the proposed rule are due **November 25, 2013**. For more information about how to submit comments, please refer to the instructions in the Federal Register.

CMS Acts to Increase Public Understanding of Medicare Open Enrollment

To help providers disseminate information on Medicare Open Enrollment (**October 15-December 7, 2013**), and to reduce confusion about whether the Health Insurance Marketplace (with a similar open enrollment period) affects Medicare beneficiaries, CMS has released several drop-in articles, public service announcements and flyers. The attached documents include:

- A drop-in article for beneficiaries about Medicare Open Enrollment including a statement intended to reduce confusion about the Health Insurance Marketplace: "The new Health Insurance Marketplace won't affect your Medicare coverage and is not part of the Medicare Open Enrollment..."
- A drop-in article for providers about Medicare Open Enrollment
- A drop-in article regarding Medicare's Extra Help program that assists people with limited income to pay for their prescription medications
- Live-read radio public service announcements (30/60 second) on Medicare Open Enrollment for distribution to media, partners, providers and other stakeholders
- Writable flyers to help organizations advertise Medicare Open Enrollment events and get the word out

Consumer Financial Protection Bureau

CFPB Releases a Guidance to Financial Institutions to Help Spot Elder Financial Exploitation and Abuse

Older Americans are often targeted by scam artists, family members, financial advisers, caregivers, home repair target, among others. Financial institutions often spot the red flags for

abuse sooner than anyone else can, but their employees may be confused about whether privacy laws allow them to share information with authorities that can take action.

Along with other federal regulators, the Consumer Financial Protection Bureau (CFPB) released guidance which clarifies for banks and other financial institutions that they generally may report suspected elder financial exploitation to the appropriate authorities without breaking a federal privacy law.

From Congress

Five Members of Federal Long-Term Care Commission Issue Alternative Report

On September 23, 2013, five members of the Commission on Long-Term Care issued an alternative report, *A Comprehensive Approach to Long-Term Services and Supports*, outlining and discussing their recommendations to address the challenges facing our country's long-term services and supports (LTSS) system. The five Commissioners include: Laphonza Butler, Henry Claypool, Judith Feder, Lynnae Ruttledge, Judith Stein.

In explaining their decision to author a minority report, the Commissioners "acknowledge[d] the efforts of the entire Commission and staff," but expressed their dissatisfaction with the full Commission's recommendations, which they did not endorse. Accordingly, to "express [their] shared vision of what is necessary to meet Congress's mandate to establish and finance a high-quality, comprehensive LTSS system for Americans who need such services," the dissenting Commissioners decided to issue their own set of recommendations, which incorporate their articulated vision to create "an inclusive LTSS system for people of all ages - a system that will meet individual's functional and cognitive support needs with quality care in the most integrated setting. We are convinced that no real improvements to the current insufficient, disjointed array of LTSS and financing can be expected without committing significant resources, instituting

federal requirements, and developing social insurance financing" (Excerpt from *A Comprehensive Approach to Long-Term Services and Supports*, September 23, 2013).

Senator Harkin's New Report Offers Steps to Improve Employment of Young People with Disabilities

On September 26, 2013, U.S. Senator Tom Harkin (D-IA), Chairman of the Senate Health, Education, Labor, and Pensions (HELP) Committee and co-author of the Americans with Disabilities Act (ADA), released a report, *High Expectations: Transforming the American Workforce as the ADA Generation Comes of Age*. The report offers bold steps to improve the employment of the 'ADA Generation' - young men and women who have come of age since ADA was enacted, and who are now seeking competitive employment.

Chairman Harkin's report identifies four key areas of opportunity to improve support for members of the ADA generation as they seek competitive employment:

- Increasing support for high school students as they plan for their transition into the workforce
- Improving the transition of the ADA generation as they enter postsecondary education and the labor market
- Changing the assumptions in disability benefit programs that discourage young people with disabilities from working
- Leveraging employer demand, correcting misconceptions about employing people with disabilities, building strong pipelines from school to the competitive workforce, and establishing supportive workplaces.

The Senate Health, Education, Labor, and Pensions (HELP) Committee is scheduled to mark up legislation to reauthorize the Older Americans Act on Wednesday, **October 2**. The legislation, which has yet to be formally introduced, represents the bipartisan efforts of the HELP Committee leadership, and that of the Subcommittee on Primary Health and Aging. The Hilltop Institute Releases Second Issue Brief on Hospital Community Benefits

The Hilltop Institute's Hospital Community Benefit Program has just released a second issue brief related to its online resource, the Community Benefit State Law Profiles. This brief, *Hospital Community Benefits after the ACA: Policy Implications of the State Law Landscape*, describes state community benefit requirements organized into eight categories that largely reflect either pre-existing federal community benefit standards or additional requirements set forth in §9007 of the Affordable Care Act (ACA). It also compares and contrasts various states and discusses the policy implications of the findings.

The first issue brief, *Hospital Community Benefits after the ACA: The State Law Landscape*, presented the Community Benefit State Law Profiles' initial findings. This brief also began the analysis to facilitate a better understanding of each state's community benefit landscape, and its significance in the context of national health reform.

The Community Benefit State Law Profiles are a compilation of each state's community benefit laws and regulations, analyzed in the context of the ACA's community benefit framework. Funding Opportunities

ACL Veterans Transportation "Highly Rural" Transportation Grants

A funding opportunity provided by the Administration for Community Living (ACL) by the Veterans' Transportation Program to provide service in highly rural areas is accepting applications through **October 9th, 2013**.

The purpose of the program is to provide grants to eligible recipients to assist veterans in highly rural areas through innovative transportation services to travel to VA medical centers and to other VA and non-VA facilities.

Eligible organizations are Veteran Service Organizations and State Veteran Service Agencies recognized by the Secretary of Veterans Affairs. Non-eligible organizations such as an AAA, ADRC, State Agency on Aging and Disability, or local transportation provider would have to partner with the above organizations and provide the services as sub-recipient.

Grantees can receive \$50,000 for each highly rural area for which they provide transportation services. No matching funds are required.

CMS MFP Tribal Initiative Funding

On **July 23, 2013**, CMS announced a Money Follows the Person (MFP) Tribal Initiative (TI) funding opportunity. The MFP-TI offers existing MFP state grantees and tribal partners the resources to build sustainable community-based long term services and supports (CB-LTSS) specifically for Indian country. The TI may be used to advance the development of an infrastructure required to implement CB-LTSS for American Indians and Alaska Natives (AI/AN) using a single, or a variety of applicable Medicaid authorities.

Closing date for applications is **October 17th, 2013**.

Funding is intended to support the planning and development of:

1. An in-state Medicaid program CB-LTSS, as an alternative to institutional care, tailored for AI/AN who are presently receiving services in an institution;
2. A service delivery structure that includes a set of administrative functions delegated by the state Medicaid agency to Tribes or Tribal organizations;
3. The TI may be used to cover costs necessary to plan and implement activities consistent with the objectives of this funding and within Federal grant regulations. The funds are subject to all the terms and conditions of the MFP Program.
