SC Access is a web based and hosted application written by Visionlink, Inc. and running on their servers housed in multiple locations in Colorado to mitigate single location disasters and facilitate disaster recovery.

The LGOA has been working with and using Visionlink's system for ten years. The contract is renewed yearly in the fall at around \$22,000. The contract based upon the number of portals (about \$2,000 each) and the number of resources in the database (currently around 13,000). We do not incur any per user licensing fees and have 118 active users. We currently have two active portals right now, one for ADRC contact management and one for SHIP contact management, and a third for testing.
