domestic intelligence communities continually harass me with acoustical, optical, psychological, physiological, unauthorized surveillance plots, and unauthorized tracking devices in various public locations. These are very unsafe practices of the domestic intelligence community which clearly violates the Department of Defense Directive 3025.21.

It should be noted that it is the continual abuse and misuse of lethal and nonlethal weapons by members of the domestic intelligence community and civilian law enforcement agencies in America that also contribute to the increase of individuals with mental illnesses and various physiological health problems (United States Army Intelligence and Security Command, 2006). Moreover, (Weatherston & Moran, 2008) argued that while mental illness disorders are not the primary cause for individuals' participation in domestic terrorism and extremist activities, individuals who engage in such negative practices are likely to acquire various mental illness disorders. With this said, the domestic intelligence community and civilian law enforcement agencies must cease the wrongful abuse and misuse of lethal and nonlethal weapons against its citizens, as it only increase the occurrence of individuals willingness to engage in extremist and terrorist activities in America. We must be mindful that the overall purpose of the 1986 Department of Defense nonlethal program was to minimize deaths, casualties, injuries, and/or damages to military and civilian “law enforcement officers, suspects, prisoners, general public, and environmental surroundings and properties” (United States Department of Justice, 2004).

The enclosures sections 3 and 4 of the Department of Defense Directive 3025.21 “restrict the participation of the Army and Air Forces in Posse Comitatus Act. These enclosures further restrict the direct participation of the Army, Navy, Air Force, and/or Marine Corps in civilian searches, seizures, arrests, and other similar activity unless authorized by law to assist civilian law enforcement agencies” (United States Department of Defense, 2014). Moreover, these

enclosures restrict the Department of Defense personnel participation in direct “surveillance or pursuit of individuals, vehicles, items, transactions, physical locations, acting as undercover agents, informants, investigators, or interrogators” unless authorized by appropriate law officials (United States Department of Defense, 2014).

Nowhere, in my research did I notice the approval of the American domestic intelligence community and civilian law enforcement agencies to use nonlethal weapons in my home, travels, workplace, and vacation lodging facilities in the current capacity without a court order, warrant, or an authorized written consent.

As a result, it is this citizen’s request for each of you to work together to resolve this matter as soon as possible to ensure that these unlawful and compromised actions within the American domestic intelligence communities and civilian law enforcement agencies are ceased and prohibited in the near future against every citizen within America. In addition, if my name has been erroneously placed on a list as a direct or indirect target for intelligence surveillance please notify me immediately of such federal court actions or otherwise stop harassing me with the various military devices.

Finally, the most effective way to improve and enforce appropriate practices of the domestic intelligence and civilian law enforcement programs across America is for the President of the United States, members of Congress, members of the Intelligence Community, members of the civilian law enforcement agency, and American citizens to collaborate political paradigms to existing policies and legislation that currently address the appropriate usage of lethal and nonlethal weapons in America. For example, the regulations and procedures in the Department of Defense Directive 3025.21; Massachusetts: Chapter 170 of the Acts of 2004; Maine: Chapter 264 H.P. 868 - L.D. 1271 (2005); Michigan: House Bill 4513 (2004) Public Act No. 256; and

Dear Constituents,

This is a letter to report the lack of implementation and enforcement of the Department of Defense Directive 3025.21 policy in New York, New Jersey, Pennsylvania, Georgia, and South Carolina during my travels in 2014, and at my current location. While, I am pleased that the Department of Defense developed this policy aligned to my February 27, 2013 complaint against the American domestic intelligence community, I remain very disappointed that various domestic intelligence communities have not adhered to the directives of this policy and continually violate my 3rd and 4th amendment constitutional rights. Therefore, the purpose of this correspondence is to notify each of you that the major problem in America's domestic intelligence community is the lack of effective checks and balances to monitor accountability and enforceability of the Department of Defense regulations and policies.

The active duty military employees of the various domestic intelligence communities constantly use nonlethal devices in my home, automobile/aircraft travels, workplace, and vacation lodging facilities to surveillance my physical activities and to communicate inappropriate audio messages to me through low frequency infrasound waves from long distances. The various intelligence communities and civilian law enforcement agencies do not have court orders, warrants, or written consents from the homeowners and/ or company stakeholders to directly violate my right to be secure as a person, in my house, with private papers/writings, and effects against unreasonable searches and seizures through the direct usage of lethal and nonlethal weapons in America. The active duty military members of the various
