



Hazard Mitigation (HM)

Hazard Mitigation and Community Education and Outreach: Mitigation Advisors, staffing 29 DRCs, advised 458 survivors. Cumulative interview total is 9,928. Cumulative totals: advised 9,702 and approached 21,900.

Floodplain Management and Insurance: Floodplain Specialists completed General Technical Visits (GTA) and updated the Community Information System (CIS) for cumulative total of 111 of 139 planned visits.

Substantial Damage Estimator: Inspectors completed 4,921 inspections; 89.5% of the adjusted original inspection goal.

Hazard Mitigation Grant Program: The State announced HMGP "Notice of Funding" Statewide disaster.

- EHP staff supported Public Assistance by participating in seven (7) Kick-off meetings. Staff delivered an overview of EHP requirements for project compliance and distributed Greensheets and Quick Guides.
