Thank you all very, very much for pulling together this letter. I am sorry I may have seemed abrupt on Wednesday as I redirected you to Mike, but it was Yom Kippur, I wasn't supposed to be working, and I was just in between afternoon and evening services at the synagogue.

Our hearing at the Department of Commerce was yesterday morning (at 8:00 A.M.). We were listening for any reference to the manpower training issue, even oblique. There was none. Because it is not a major issue in the case and did not arise until very late in the investigation, we wanted to address it strongly if it seemed to become more serious, but we have not wanted to spotlight it. Under the circumstances, we have thought it most prudent not to submit the letter from your office now, but instead wait to see how the Department of Commerce elects to address the issue in its final determination, which is due October 14.

We apologize, of course, for any imposition we may have caused. We are grateful for the speed and understanding you devoted to this issue. And, we may yet want to return to the letter, but for now we are letting the sleeping dog lie. We wanted you to know the situation, and we will let you know what happens on October 14.
