The oddest thing has happened. In the wake of the 2016 election and Hillary Clinton's loss, South Carolina has inadvertently positioned itself to become the state that could produce the nation's first woman president: Nikki Haley. Back in January, I wondered if Gov. Haley had missed her window to take advantage of her enormous political potential on a national stage. She's smart, a quick-learner and one of the craftiest politicians in the nation. Yet instead of running for the top job, she was then giving the GOP response to President Obama's final State of the Union address and being talked up as a vice presidential prospect for candidates who soon washed out of the race. Now, it looks as though that window may not be closed after all, as Haley is reportedly in the running to be secretary of state in the Donald Trump administration. If, as the daughter of Indian immigrants, she becomes America's top diplomat (or even if she manages her consideration wisely), she will be back in line to do in her party what Obama did in his: break barriers while backed by a diverse coalition of Americans.

**NOTE:** But regardless of whether she actually gets this job, it's clear to me that those who dismiss Haley are making a serious mistake. I was there when Haley came through Myrtle Beach during her first run for governor and was being mocked then, too, by experts who said she had no shot in a state who had only elected white men for its highest office. Anyone paying attention to how she handled questions during press conferences way back then could see how clear it was that she was a force to be reckoned with. She was then dismissed again during her first term as she traded elbows with a Republican-controlled General Assembly not always allied with her -- until she got the job done, again and again.

Sen. Lindsey Graham gave his full support to both Rudy Giuliani and John Bolton as picks for secretary of state by the incoming Trump administration, while chiding critics like Sen. Rand Paul who have vowed to oppose the potential nominees. "You can put the Republicans in a very small car who are going to follow Rand Paul's advice when it comes to national security," Graham told CNN's John Berman and Kate Bolduan on "At This Hour." "He is my friend, he's a libertarian, but he's an outlier." "Graham expressed confidence that both Giuliani and Bolton could be confirmed as heads of the State Department despite early opposition from Paul and Democrats, who have seized on Giuliani's international consulting work and paid speaking engagements -- something Hillary Clinton was criticized for -- as potential conflicts of interest. He also dismissed Paul's complaint about the hawkish Bolton since his recess appointment during the Bush administration.

**NOTE:** Graham also said he could support another potential candidate -- his state's governor, Nikki Haley -- though his backing was more lukewarm. "I would say (Haley) did a good job as governor of South Carolina. She's talented, she's capable. I think she could do a good job in any assignment given. I don't know about her foreign policy. I haven't talked to her," he said, adding later, "At the end of the day, I would support her."

South Carolina Rep. Mark Sanford doesn't want Donald Trump's Cabinet to look like a "Benetton commercial" but he does think Gov. Nikki Haley's Indian heritage could help her if she was secretary of State. Sanford was speaking to MSNBC Thursday when he was asked about reports that his state's governor was being considered for secretary of State. President-elect Trump and Haley were scheduled to meet in New York Thursday. "I don't think the Cabinet needs to look like a Benetton commercial, but I think having folks of different ethnic backgrounds matters, particularly in that role. Given we're 5% of the world's population and most of the world doesn't look like us," he said. Benetton commercials are known for their diversity. In February Haley, who had endorsed Florida Sen. Marco Rubio — a Cuban-American — for president, said the new group of conservative leaders "looks like a Benetton commercial."

Amid swirling speculation about his Cabinet picks, President-elect Donald Trump is in Trump Tower in New York City for another full day of meetings, where he is believed to be narrowing down his possible choices, with nominations expected within the next few weeks. Since his visit to Washington, D.C., last week, Trump has remained in his Manhattan headquarters and residence, with no public events, holding multiple meetings with top transition aides and various contenders for his Cabinet. The meetings today were likely to focus on foreign policy and national security, including a mix of people who are providing counsel and those whose names are reportedly in the mix for Cabinet positions in the Trump administration.

NOTE: Among those who visited or were expected to head to Trump Tower today: Sen. Jeff

Sessions, R-Ala., a contender for attorney general; South Carolina Gov. Nikki Haley, a possible secretary of state; and former Secretary of State Henry Kissinger.

NOTE: Haley, a late endorser of Trump, originally threw her support behind Florida Sen. Marco Rubio before the South Carolina primary in February. "Marco Rubio is the only one that can defeat Donald Trump, and Marco Rubio can beat Hillary Clinton and will win in November," Haley said on ABC News' "This Week" in February.

NOTE: Sen. Lindsey Graham, R-S.C., voiced his support for Haley today, telling CNN, "She's talented, she's capable and could do a good job in any assignment given. I don't know her foreign policy. I haven't talked to her. Her husband was in the South Carolina National Guard. He deployed to Afghanistan. I think she's a traditional Republican when it comes to foreign policy. I certainly would support Nikki Haley. I like her a lot."

NOTE: "Gov. Haley was pleased to meet with President-elect Trump," her deputy chief of staff Rob Godfrey said in a statement to ABC News after the meeting. "They had a good discussion, and she is very encouraged about the coming administration and the new direction it will bring to Washington."

On the day President-elect Donald Trump will gather with the first foreign head of state since his election victory, top senior adviser Kellyanne Conway joined "CBS This Morning" and gave a preview of the meeting, to be held with Japanese Prime Minister Shinzo Abe. "I think any deeper conversations about policy and the relationship between Japan and the United States will have to wait until after the inauguration," Conway said Thursday when asked whether Mr. Trump and Abe would discuss the businessman's campaign trail promises to make Japan pay for its own defense. "Maybe they'll discuss that today," she added, but went on to say that it would be a "much more informal meeting than all of that since we have a current president and commander-in-chief." Conway weighed in on other news of the Trump transition team, including Mr. Trump's son-in-law, Jared Kushner, who was reportedly seeking national security clearance earlier this week.

NOTE: On other names floated for Cabinet positions, Conway discussed the possibility of the secretary of state post getting filled by South Carolina Gov. Nikki Haley, once a vocal critic of Mr. Trump's rhetoric on the campaign trail.

NOTE: "It would probably be irresponsible to go ahead and name all the people right at once," Conway said. "But we're very happy that Governor Haley is coming to meet with President-elect Trump. I'm sure they'll have a broad-- a wide ranging conversation."

From the top job in a state with no international borders, to maybe becoming the nation's chief diplomat, everyone is wondering whether President-elect Donald Trump will pop the question. After a whirlwind 24 hours of speculation, Gov. Nikki Haley met face-to-face Thursday with a previous political foe inside downtown Manhattan's Trump Tower. Neither side disclosed details of what was discussed, but Haley's long-shot possibility of becoming the nation's next secretary of state was widely considered the topic. "They had a good discussion, and she is very encouraged about the coming administration and the new direction it will bring to Washington," a Haley spokesman said in a statement after their midday session. While Haley has received high marks for handling domestic

matters at home, her resume includes next to no experience in national security or foreign affairs, indicating the job may be a tough sell to the American people.

SC Gov. Nikki Haley traveled to New York City to meet with President-Elect Donald Trump Thursday, though there was no news yet of a new position for her in his administration. Haley met with Trump at his office in Trump Tower, and Rob Godfrey, Haley's deputy chief of staff, said the meeting went well. "Governor Haley was pleased to meet with President-elect Trump," Godfrey said in an emailed statement. "They had a good discussion, and she is very encouraged about the coming administration and the new direction it will bring to Washington."

Reports had been circulating that both Haley and Lt. Gov. Henry McMaster were being considered for positions in Trump's administration. News outlets reported South Carolina's governor was being considered for the job of secretary of state, while McMaster, an early Trump supporter, could become Trump's attorney general. The meeting comes the day after Haley was named vice chair of the Republican Governors Association, a nationally visible post that puts her in line to become the chair of the association in 2018.

With chatter that GOP Gov. Nikki Haley and Lt. Gov. Henry McMaster have been approached by President-elect Donald Trump's transition team about joining his administration, some are asking: What happens if one or both leave their S.C. posts? If only Haley leaves. If Haley gets a position in the Trump Administration — secretary of state or secretary of commerce have been speculated — McMaster would rise to the governor's office. That would give the Columbia Republican two years in office before he likely would run again for the governor's office in 2018. McMaster, a former S.C. attorney general, ran for the GOP nomination for governor in 2010 but endorsed Haley after placing third in the Republican primary. That would leave the lieutenant governor's office open, which would be filled by the president pro tempore of the Senate. State Sen. Hugh Leatherman, R-Florence, is president pro tempore of the Senate. However, the power of the Senate leader, who controls appointments to many state government panels, along with Leatherman's chairmanship of the Senate's powerful budget-writing committee far outweighs the influence wielded by the state's lieutenant governor.

The appointment of Gov. Nikki Haley or another South Carolina politician to President-elect Donald Trump's cabinet could have a serious impact on the state. Haley met Thursday with Trump in New York. The governor's office did not say what the pair discussed, but Lt. Gov. Henry McMaster has said Haley is under consideration for multiple cabinet positions, including secretary of state. If Haley were to join the Trump Administration, McMaster would assume the governorship, a position he has publicly considered running for in 2018. That could mean an advantageous position for McMaster, giving him experience with the job before campaigning begins. Two candidates — House Speaker Pro Tempore Tommy Pope and former Lt. Gov. Yancey McGill — have already publicly stated their intention to run for the Republican gubernatorial nomination, and multiple others are openly entertaining the idea.

Gov. Nikki Haley is expected to meet with President-elect Donald Trump today in New York, according to the president-elect's press pool. Lt. Gov. Henry McMaster says he has spoken to President-elect Donald Trump's transition team and he's open to taking a role in his administration. In brief remarks since Trump's stunning electoral victory last week, McMaster, who was one of the first mainstream Republicans to endorse Trump in the wide-open Republican primary in January 2016, said he wants to help Trump in the next four years. Twenty years ago, U.S. Rep. Trey Gowdy was a federal prosecutor sharing a desk in a windowless basement office. Today, he could be under consideration for the position of U.S. attorney general. Gowdy, who currently represents most of Greenville and Spartanburg counties in the U.S. House of Representatives, is on President-elect Donald Trump's short list for the country's top prosecutor, according to multiple reports. Others thought to be under consideration include Florida Attorney General Pam Bondi and Alabama Sen. Jeff Sessions. Lt. Gov. Henry McMaster, a former S.C. attorney general, has said he is also being considered for the position. Gowdy is currently focused on his work in the House, said press secretary Amanda Gonzalez. The Republican caucus, of which Gowdy is a member, will soon begin doling out committee chairmanships and assignments for the coming legislative session. The Spartanburg Republican was just re-elected to his fourth term in Congress.

**Associated Press:** Trump reassuring the world he's focusing on foreign policy

Donald Trump sought to reassure nervous leaders around the globe with his most public foray into foreign policy since the election, welcoming Japan's prime minister to Trump Tower on Thursday. On Capitol Hill, his incoming vice president aimed to project unity at home. Trump planned a face-to-face meeting late Thursday with Shinzo Abe, his first with a world leader since last week's vote, after consulting with former Secretary of State Henry Kissinger and sitting down with South Carolina Gov. Nikki Haley, a potential contender to lead the State Department. In Washington, Vice President-elect Mike Pence huddled with Republican leaders in Congress. He then met with House Minority Leader Nancy Pelosi and Sen. Chuck Schumer, the newly elected leader of the Senate Democrats, seeking to convey respect as Democrats prepare for Republican rule of both chambers and the White House for the first time in a decade. "We look forward to finding ways that we can find common ground and move the country forward," Pence said outside Schumer's Senate office.

As one of President-elect Donald Trump's closest and most consistent allies, Sen. Jeff Sessions is a likely pick for a top post in his administration. But when Sessions faced Senate confirmation for a job

30 years ago, it didn't go well. Nominated for a federal judgeship in 1986, Sessions, R-Ala., was dogged by racist comments he was accused of making while serving as U.S. attorney in Alabama. He was said to have called a black assistant U.S. attorney "boy" and the NAACP "un-American" and "communist-inspired." Sessions was the first senator to back Trump during the campaign and is an architect of Trump's immigration, counterterrorism and trade policies. His name has been floated for attorney general and secretary of defense. The Trump transition team released a statement Thursday saying the president-elect is "unbelievably impressed" with Sessions, citing his work as a U.S. attorney and state attorney general in Alabama. But confirmation for the four-term lawmaker, even in a Republican-controlled chamber, is not guaranteed.

Want a top job in Washington? Saying less is usually the way to get more. But contenders — and wannabe contenders — for spots in President-elect Donald Trump's administration are upending that tradition. They're touting their qualifications in public appearances and chatting openly about their interactions with Trump's team. They're handicapping their rivals. Some of those who appear to be under the most serious consideration are conspicuously strolling by the pack of journalists gathered in the Trump Tower lobby on their way to meetings with the president-elect and his team. Former New York Mayor Rudy Giuliani set the tone. After declaring that he wouldn't serve as attorney general, Giuliani was asked whether there were better choices for secretary of state than some of names being bandied about. "Maybe me," Giuliani said with a grin. Shortly after, a senior Trump official confirmed Giuliani was indeed under consideration to become the nation's top diplomat.

Supreme Court Justice Samuel Alito issued a rallying cry to conservatives Thursday amid newfound strength following Donald Trump's election. Alito told the Federalist Society conference of conservative lawyers, judges and legal thinkers that religious freedom and gun rights are among "constitutional fault lines," important issues at stake in the federal courts. The conference of 1,800 of conservatism's leading lights took on a new air of importance with Trump's victory, and included a list of judges the president-elect has named as candidates to fill the vacancy created by the death last February of Justice Antonin Scalia. In his remarks, Alito didn't mention the election or the vacancy, rather using the platform to pay tribute to Scalia, a longtime colleague and conservative ally in high court battles on hot-button social and political issues. He said Scalia, a hero to many of the group's 40,000 members, is sorely missed on the court. "We are left to ask ourselves WWSD," what would Scalia do, Alito said. The lettering is a play on the phrase "WWJD," for what would Jesus do.

**Associated Press:** Obama, nudging Trump, says he must 'stand up' to Russia

President Barack Obama prodded Donald Trump on Thursday to take a tougher approach toward Russia, urging the president-elect to "stand up" to Moscow when it violates global norms. The Kremlin accused Obama of trying to lock in bad relations before Trump takes office. In Europe for his last time as president, Obama said he doesn't expect Trump to mirror his own strategy on Russia, and hopes his successor will work constructively with the superpower where appropriate. Yet he insisted the U.S. mustn't gloss over deep disagreements over Syria, Ukraine and basic democratic values. "My hope is that he does not simply take a realpolitik approach," Obama said, using a German term for a foreign policy driven by expediency. He said he hopes the businessman won't cut deals with Russia if it hurts other countries or "just do whatever is convenient at the time."

American Jews gathered Thursday to wrestle with how they should confront an election-year surge in anti-Semitism, a level of bias not seen in the U.S. for decades. At a national meeting of the Anti-



Defamation League, the Jewish civil rights group, about 1,000 people listened to talks expressing shock at the hatred expressed during the presidential campaign and questioned what they thought was a high-level of acceptance by other Americans."I'm struggling right now in this American moment," said Yehuda Kurtzer, president of the Shalom Hartman Institute of North America, an education and research organization, in his talk at the event. "I wonder whether I have been — and I think the answer is probably yes — a little bit naive."During this past year, anti-Semitic imagery proliferated on social media, Jewish journalists were targeted and longstanding anti-Jewish conspiracy theories got a fresh airing. Much of the bias originated with the alt-right, or alternative right, a loose group espousing a provocative and reactionary strain of conservatism. It's often associated with far right efforts to preserve "white identity," oppose multiculturalism and defend "Western values."

Virginia Sen. Tim Kaine says he'll seek re-election in 2018 but is ruling out a presidential bid in 2020. The former Democratic vice presidential nominee said in an interview with The Associated Press on Thursday that his place is in the Senate and his decision not to run in 2020 is final."Period. Full stop," Kaine said. With a heightened national profile after campaigning across the country for more than three months as Hillary Clinton's running mate, Kaine could have chosen to pursue his own White House ambitions or tried and play a leading role charting a reeling Democratic Party's direction in the Donald Trump era. But the first-term senator and former governor said he belongs in the upper chamber, where he will be part of a Democratic minority whose ability to filibuster will be "the only emergency brake there is" on Trump and the GOP-controlled Congress. Kaine has already been a vocal critic of Trump's appointment of Steve Bannon as a senior advisor. Kaine said Bannon's ties to white nationalism and anti-Semitism disqualify him from a senior role in the White House.

In 2008, Sanford, as governor, led a movement against the ID. He argues it is an unfunded mandate and threatens personal privacy. If states aren't compliant with the REAL ID act by Jan. 20, residents won't be able to enter a federal building or military base. On Jan. 22, 2018, the Transportation Security Administration won't accept non-compliant identification at airports. Congress approved the move in 2005 to tighten identifications following the Sept. 11, 2001, terrorist attacks.

Asthma sufferers and others with breathing problems are turning up at hospitals and doctors' waiting rooms, wheezing and hacking. Schoolchildren are being kept inside at recess. And people whose lungs are easily irritated are being told to close the windows and run the air conditioner if they have one. Dozens of wildfires that have burned an estimated 190 square miles across the Southeast have thrown a shroud of smoke over the region in the past week or so, even in distant metropolitan areas like Atlanta, leaving cities big and small smelling like a campfire jamboree, but without the fun. The murk - sometimes yellowish-brown, sometimes gray or milky - has veiled mountaintops, obscured Atlanta skyscrapers and intermittently turned the sun into a pale golden smudge over the city. At times, the flames have also cast a haze over Nashville and Chattanooga, Tennessee, and Charlotte, North Carolina.

Pickens County Schools announced a two-hour delay for the start of school Friday as firefighters worked to contain the Pinnacle Mountain wildfire and residents evacuated the nearby area Thursday. "We expect the current large-scale burnout operation on the Pinnacle Mountain fire to create heavy smoke, which will combine with existing air pollutants to create dangerous air quality conditions in parts of the county, especially in the morning," said school district spokesman John Eby. "Parents have the discretion to keep their children home from school all day, and all absences will be excused for the day." Meanwhile, unfiltered sunlight poked through smoke for the first time in days Thursday as ash flurried onto Missie Hunter's front porch at the edge of the wildfire evacuation zone. Emergency-management officials opened a shelter for displaced families as the state Forestry Commission and firefighters prepared a controlled burnout to tame the largest wildfire in the South Carolina mountains in modern history.

Firefighters will take aggressive measures on Thursday to bring the Pinnacle Mountain wildfire under control by burning more than 2,000 acres ahead of the fire, officials said Wednesday. Local fire departments are going door-to-door to evacuate about 70 families who live in the affected area close to the burnout operation. The evacuation affects the area north of State 11 from Back Park Road to South Saluda Road and north to Table Rock Reservoir, according to Russell Hubright, spokesman for the SC Forestry Commission. Fire officials are concerned about a cold front moving into the Upstate that will bring high winds and lower humidity, he said. The burnout affects both sides of Table Rock and will extend north to the Table Rock Reservoir, south to the Pinnacle Lake area, and east to the Table Rock State Park boundary near High Low Gap. The burnout also will significantly increase the amount of smoke in the air, Hubright said. The smoke on Wednesday forced state health officials to declare another air quality alert, while the prospect for rain to ease the situation remained grim.

The Pickens County Council declared a state of emergency today, one week after a major forest fire broke out on Pinnacle Mountain. The declaration is necessary to qualify the county for state and federal disaster relief funds. It will also give County Administrator Gerald Wilson wide leeway in managing the county's fire response and cleanup. "That's the big motivation for it," said Roper. "It will give the administrator some authority to free up money" from other county funds to cover fire-related expenses. County Emergency Management Director Denise Kwiatek said after the council vote that the declaration would allow Pickens County to bring in more local, state and federal agencies for help. The state of emergency would also allow Wilson to mandate an evacuation, unlike the voluntary one issued Saturday.

Nearly six dozen families in northern Pickens County have been asked to leave their homes while firefighters conduct a large-scale burnout operation Thursday to stop the spread of a growing wildfire.

So far there have been no injuries or damaged structures resulting from the 3,283-acre wildfire that was started last week by an errant campfire, S.C. Forestry Commission spokesman Russell Hubright said Wednesday.

Thursday's burnout will cover about 2,000 acres and "will put a tremendous amount of additional smoke in the air in northern Pickens County," Hubright said. "Motorists traveling in the area are urged to use caution and avoid SC 11, and people with respiratory conditions are encouraged to stay indoors," he said. An area north of SC 11 that is close to the burnout operation, from Back Park Road to South Saluda Road and north to Table Rock Reservoir, will be evacuated Thursday. Residents are being told to prepare to be away from their homes for 72 hours, according to Pickens County Emergency Management.

A massive burnout of 2,000 acres of forest land in northern Pickens County is underway in an effort to contain the Pinnacle Mountain fire, the largest mountain wildfire in South Carolina history. National Guard helicopters began Thursday morning at the northern face of Table Rock near the reservoir by dropping small "ping pong balls" of chemical powder that ignite upon hitting the forest floor, Hubright said. By Thursday afternoon, the burn is expected to encompass both sides of Table Rock to the reservoir, south to the Pinnacle Lake area, and east to the Table Rock State Park boundary near High Low Gap, Hubright said. Bulldozers, fire trucks and fire crews with hand tools are working the wildfire today to keep the controlled burn within established lines, Hubright said.

The air quality of more than half of South Carolina's counties was declared unhealthy Wednesday by the state's health agency. Just six days after the S.C. Department of Health and Environmental Control warned of possible side effects related to the wildfires burning throughout several Southeastern states, the agency issued a "Code Red" air quality alert for 25 counties, including Richland and Lexington. Melissa Overman, assistant state epidemiologist, warned against children spending too much time outdoors, since they take in more air than adults. Kids who are suffering from the air's pollutants might complain of tightness in their chests or irritated eyes and throats. Overman said healthy athletes should consider limiting their time outside as well. She also suggested not taking pets for a jog. Plus, those with respiratory illnesses, such as asthma and bronchitis, who live in the areas that will remain under code red on Thursday should remain indoors as much as possible, she said.

Todd Kohlhepp, a registered sex offender and felon, bought and sold real estate for 10 years without ever drawing the attention of state regulators. It wasn't until he was arrested and charged with the kidnapping of missing Anderson woman Kala Brown, who was found alive in a container on his property, that Kohlhepp ever faced any kind of disciplinary action from the S.C. Real Estate Commission. The commission, which oversees and regulates licensing for agents and brokers, temporarily suspended Kohlhepp's real estate license on Nov. 4, stating "the public safety and welfare imperatively requires emergency action." Kohlhepp's seemingly clean real estate record appears to be one more area in which the man charged in the deaths of four people and suspected in three others flew beneath the radar of authorities. Since 2009, Kohlhepp was the owner and broker in charge of TKA Real Estate, which is now closed. Before that, he worked as a sales associate for Weichert Realtors.

Defense attorneys for the North Charleston officer who killed Walter Scott want to tell jurors that Scott was cursing the police during a struggle with the lawman. Their evidence is based on an expert's interpretation of the sound featured in a video showing patrolman Michael Slager firing eight times as Scott ran away. But the defense case revolves around what happened before the shooting, and the lawyers contend that Scott's alleged words portrayed his animus toward law enforcement and could explain his conduct that drew the officer's gunfire in self-defense. The officer's words, refined in other audio recordings, also support his account that Scott had gotten control of his Taser, the defense said. "Let go of my Taser," Slager said, according to the expert's version, "or I'll have to shoot you."

Families of nine black worshippers killed in a Charleston church got a chance Thursday to air concerns about the case to a federal judge, who reaffirmed his decision to keep defendant Dylann Roof's competency hearing next week closed to the public. Some relatives talked about how the trial delays hurt them. Others say it will be hard to deal with the proceedings in December as Christmas neared. They all asked for Monday's competency hearing to be open. "I really want you to consider what kind of a signal you are sending to the community," said Alana Jackson, granddaughter of Daniel Simmons Sr. U.S. District Judge Richard Gergel said he understood their concerns. But after also hearing from lawyers hired by The Associated Press and other media outlets, he said his mind hadn't changed. The hearing will include extensive statements made by Roof that might not be allowed at his death penalty trial. But they could find their way to jurors and taint their view of the defendant just days before jury selection is set to begin, Gergel said.

A federal judge signaled Thursday he will begin jury selection for the delayed Dylann Roof death penalty trial on Nov. 28, following the Thanksgiving holiday. And, following a 45-minute hearing at the U.S. courthouse in downtown Charleston, Judge Richard Gergel also said he will hold Monday's mental competency hearing for Roof behind closed doors. Gergel announced his decision to close Monday's hearing following emotional pleas to open it from more than a half-dozen African-American survivors and relatives of victims of the June 2015 massacre at Charleston's historic Mother Emanuel AME church. Two media lawyers, Carl Muller and Brad Lanford, representing state and national news outlets including The State, The Greenville News, The Charleston Post & Courier, NPR and the AP, also argued unsuccessfully to open Monday's hearing. Federal prosecutors, too, asked that the hearing be open. A federal indictment in the case alleges Roof, 22, a self-described white supremacist from the Columbia area, drove to Charleston in June 2015 to kill African-Americans at Mother Emanuel to "incite racial tensions across the nation," then killed in execution fashion nine people, including the church's pastor, state Sen. Clementa Pinckney.

Relatives of the nine people killed in the Emanuel AME Church massacre urged a judge Thursday to reconsider his decision banning them from Dylann Roof's competency hearing next week. U.S. District Judge Richard Gergel, however, held fast to his decision to close the hearing. Gergel found substantial risk that making the details of Roof's new psychiatric evaluation public would threaten the killer's right to a fair trial and an impartial jury. Several victims' families, the husbands of two of the shooting survivors and Emanuel's pastor lined up in a federal courtroom to press Gergel to consider their pain and rights to observe the proceedings addressing the man who gunned down their loved ones. "It would be unfair for us not to be there," said Tyrone Sanders, standing beside his wife, Felicia, who survived the shooting with their 11-year-old granddaughter by playing dead. Their son, Tywanza, was killed. "We've lost the greatest portion," Sanders added.

A federal appeals court upheld a \$2.95 million verdict in the wrongful death of a Berkeley County jail inmate in 2010. The U.S. 4th Circuit Court of Appeals upheld the verdict on Wednesday, according to court documents. The money was awarded to the mother of David Allan Woods, 50, who died on Nov. 11, 2010, after spending a month at the Hill-Finklea Detention Center, as the jail is formally known. Woods died of gastrointestinal bleeding caused by ulcers, cirrhosis and dilated veins in his esophagus known as varices, according to information from the autopsy included in court documents. He started complaining about vomiting blood and having bloody stools but jail staff ignored his condition, according to the documents.

Bosch makes advanced fuel injectors and anti-lock brake system components in North Charleston. **Associated Press:** After Muslim backlash, lawmaker drops change to no-mask law

Advocates accused a Georgia lawmaker of targeting Muslim women with proposed changes to a 1951 state law passed to unmask the Ku Klux Klan, creating a backlash that prompted the Republican legislator to quickly discard the idea. State Rep. Jason Spencer came under fire from the American Civil Liberties Union and Muslim advocacy groups who called his proposal a veiled attempt to ban Muslim women from wearing scarves and other religious headgear that covers their faces in public — just as the law has prohibited Klan members from wearing masks during rallies and marches on public property. "It is a naked and despicable attempt to exploit the current wave of anti-Muslim sentiment by targeting Muslim women," Heather Weaver, an attorney for the American Civil Liberties Union in Washington, said Thursday. Spencer said the bill he introduced for next year's session of the Georgia Legislature would simply be "adding clarity" to a law passed decades ago to safeguard against what he called "threats from masked terrorists." And he insisted he wasn't targeting any specific group.

**Associated Press:** Appeals court blocks 'Making a Murderer' inmate's release

A Wisconsin prison inmate whose case was featured in the Netflix series "Making a Murderer" will stay behind bars while state attorneys appeal a decision overturning his conviction, a panel of federal appellate judges ruled Thursday. Brendan Dassey's release from prison appeared imminent right up until the three-judge panel from the 7th U.S. Circuit Court of Appeals in Chicago issued its decision. Television crews and reporters were staking out the prison in Portage where Dassey is being held, waiting for him to walk out at any minute, when the ruling came down around midday. "We are disappointed more than words can say," Dassey's attorneys, Steve Drizin and Laura Nirider, said in a statement posted online shortly after the ruling was released. "The fight goes on." Dassey, now 27, was sentenced to life in prison in 2007 in the death of photographer Teresa Halbach two years earlier. He confessed to detectives that he helped his uncle, Steven Avery, rape and kill Halbach in the Avery family's salvage yard in Manitowoc County. Avery was sentenced to life in prison in a separate proceeding.
