Bryant will testify at a Senate Judiciary Subcommittee hearing on S. 217, The Personhood Act of South Carolina, on Thursday, March 30th at 9:30am in Gressette Building Room 308. Lieutenant Governor Bryant is the lead sponsor of The Personhood Act of South Carolina which promotes the Liberty of unborn children by codifying in South Carolina Statute that the life of a child begins at fertilization. S. 217 reaffirms that an unborn child is endowed by their Creator with the unalienable right to life guaranteed by the United States Constitution and the South Carolina Constitution.
