Dear Senator Martin:

Thank you for your inquiry regarding treatment options for recipient Kevin Tucker Brock. Mr. Brock's condition requires care that is provided in specialized facilities not routinely covered under our state plan. Also, because there are no facilities in South Carolina that provide care specific for his needs, Mr. Brock's mother has been instrumental in locating a facility in Pittsburgh and has requested assistance with having her son transferred there.

My staff has been in constant communication with the Children's Institute of Pittsburgh (CIP), as well as your office, to arrange for his care at the Children's Institute. Because this is a specialty facility, our normal reimbursement options were not applicable, however agreements for payment were initiated by the Department of Health and Human Services and approved by CIP. We were informed by staff from the Children's Institute that Mr. Brock was admitted to their facility on Monday, December 4<sup>th</sup>.
