* July 18, 2014

The Centers for Medicare & Medicaid Services (CMS) today awarded additional contracts as part of a restructuring the Quality Improvement Organization (QIO) Program to create a new approach to improve care for beneficiaries, families and caregivers. QIOs are private, mostly not-for-profit organizations staffed by doctors and other health care professionals trained to review medical care and help beneficiaries with complaints about the quality of care and to implement improvements in the quality of care available throughout the spectrum of care.

The new contracts being awarded to fourteen organizations represent the second phase of QIO restructuring. The awardees will work with providers and communities across the country on data-driven quality initiatives. These QIOs will be known as Quality Innovation Network (QIN)-QIOs.

QIN-QIO projects will be based in communities, health care facilities and clinical practices. They will drive quality by providing technical assistance, convening learning and action networks for sharing best practices, collecting and analyzing data for improvement. The U.S. Department of Health and Human Services' (HHS) National Quality Strategy (NQS) and the CMS Quality Strategy provide the framework for the contracts along with the companion, recommendations, and priorities.

* July 18, 2014

The Centers for Medicare & Medicaid Services (CMS) issued revised guidance on Part D payment for drugs for beneficiaries enrolled in hospice. CMS is modifying the March 10 guidance to Part D sponsors to place a prior authorization for all drugs for hospice beneficiaries. In the revised guidance issued today, CMS instructs Part D sponsors to use prior authorization only on the four categories of drugs that the Inspector General, in consultation with hospice providers, identified as typically used to treat the common symptoms of pain, nausea, constipation and anxiety that hospice beneficiaries generally experience during the end of life, regardless of terminal diagnosis. The categories of drugs for which hospice-related prior authorization remains appropriate are analgesics, antinauseants, laxatives, and antianxiety drugs. Part D sponsors are no longer expected to place hospice-related prior authorization requirements on other categories of drugs.

CMS expects the number of Part D claims for hospice beneficiaries for drugs in these four categories to be very few. Together with other steps taken to facilitate the prior authorization process, these limits on hospice-related prior authorization under Part D will minimize any barriers to hospice beneficiary access to prescription drugs at the end of life.

* **July 15, 2014**

HHS Secretary Sylvia M. Burwell announced the availability of \$11 million, through the Affordable Care Act and the Secretary's Minority AIDS Initiative Fund, to support the integration of high-quality HIV services into primary care through innovative partnerships between health centers and state health departments in Florida, Massachusetts, Maryland and New York. This initiative supports the goals of the Administration's National HIV/AIDS Strategy.

This funding opportunity is part of a new three-year, multi-agency project-- Partnerships for Care: Health Departments and Health Centers Collaborating to Improve HIV Health Outcomes. Run jointly by the Centers for Disease Control and Prevention and the Health Resources and Services Administration (HRSA), this project will enable HRSA-funded health centers to work with CDC-funded state health departments to expand the provision of HIV prevention, testing, care, and treatment services, especially among racial/ethnic minorities.

* **July 14, 2014**

Health and Human Services Secretary Sylvia M. Burwell announced a new innovative collaboration with states to improve care for Medicaid beneficiaries by accelerating efforts in reforming their health care systems to improve health and care while reducing costs. The goals and activities of the Medicaid Innovation Accelerator Program build on many of the recent recommendations made by the National Governors Association's (NGA) Health Care Sustainability Task Force.

This initiative is consistent with states' recommendation that the Centers for Medicare & Medicaid Services (CMS) identify opportunities for care improvement and addressing high priority areas such as mental health and emergency department utilization. Through the Medicaid Innovation Accelerator Program, HHS is investing over \$100 million in technical support to help states in their efforts to improve health, improve care and decrease costs for their Medicaid beneficiaries. While complementing other federal-state delivery system reform efforts such as the State Innovation Models initiative, this new initiative will help jumpstart innovation by providing federal tools and resources to support states in advancing Medicaid-specific delivery system reform.

* **July 18, 2014**

The Centers for Medicare & Medicaid Services (CMS) issued the Comprehensive Medicaid Integrity Plan. As mandated by the Deficit Reduction Act, the Comprehensive Medicaid Integrity Plan sets forth the strategy to safeguard the integrity of the Medicaid program during federal fiscal years 2014–2018. The execution of this Plan will improve the ability of state Medicaid agencies and CMS to leverage program data to detect and prevent improper payments, which will strengthen the ability of state Medicaid agencies to safeguard state and federal Medicaid dollars from diversion into fraud, waste, and abuse. These efforts will expand the capacity of CMS to protect the integrity of the Medicaid program and to manage risk in the administration of federal grants to states.
