Hello Dukes:

Per our conversation earlier today, Duke Energy does not view the proposals from Home Works as supporting public education and senior outreach relative to the \$1 million donation.

The purpose of the \$1 million contribution, from Duke Energy's point of view, was to be mindful of the hardship that increased rates may have for groups most vulnerable such as Seniors and to help them absorb the impact of such increase.

Duke Energy did not envision home repairs as achieving that specific goal, at least as proposed. Many of our most vulnerable senior customers are not in a financial position to own their own homes, and so we question the use of the funds for that purpose, nor did we envision donating substantial funds for "business plans" to third parties.

We had hoped that the infrastructure and guidance necessary to direct the funds to the recipients would be made up of the members of the advisory committee, not directed to a third party. We would be eager to hear of ORS's desired direction for the funds and think it may be most productive and efficient if you or a member of ORS was a part of the Committee.

I am certainly open to other suggestions as well – we just want to ensure this money will be prudently spent for the benefit of those folks it was intended to impact.
