AFFIDAVIT

Personally appeared before me, a magistrate of this County, one Detective Alexander, who, first being duly sworn, deposes and says

DEVANTE MARQUEZ WHITE

did within Charleston County and this State on or about the 13th day of December, 2014 violate the criminal laws of the State of South Carolina in the following particulars:

DESCRIPTION OF OFFENSE
MURDER
16-3-10

The affiant states that there is probable cause to believe that the defendant named above did commit the crime(s) set forth, and that such probable cause is based on the following facts:

December 13, 2014, while at the incident location of 1132-B Honey Hill Road, Charleston, SC, 29412 in the County and State aforesaid, the above named defendant, **DEVANTE MARQUEZ WHITE**, did commit the offense of violation section 16-3-10 of the South Carolina Code of Laws, 1976 as amended, **MURDER**, in that he did willfully, unlawfully, feloniously with malice aforethought **act in concert with co-defendant/gunman, Clifford Malcolm Whaley Jr.** when he (Whaley Jr) shot the victim, **IRVIN GREEN SR**, multiple times, which directly caused death to the victim.

On December 13, 2014 at approximately 1700 hours, the Charleston County Sheriff's Office (CCSO) responded to 1132-B Honey Hill Road in reference to a shooting. Upon CCSO arrival, EMS pronounced the victim, Irvin Green Sr. deceased. It was later discovered through autopsy that the victim was murdered and suffered multiple gunshots. Through investigation several witnesses, to be identified later, identified co-defendant Clifford Malcolm Whaley Jr. as the gunman.

On June 7, 2016, Detective Alexander obtained information from witnesses, to be identified later, that they were present at the incident location on the incident date. They stated that as they were near the incident location they heard approximately three gunshots. Shortly after, they saw who they know by sight and nickname "Boo", who is a good friend of Whaley Jr., leaving the incident location wearing what appeared to be a bloody white t-shirt. White was seen carrying what appeared to be the victim's black and white Nike bag that he always had in his possession which contained his currency and valuables. Family members described the victim's bag as identical to the bag in White's possession.

Through subsequent investigation, it was determined that Devante Marquez White went by the nickname Boo. His photograph was included in a photographic lineup and shown to witnesses for identification. An independent administrator showed the photographic lineup to witnesses and they positively identified White as Boo.


Cell phone records indicate that there was communication between White and the victim, Irvin Green Sr., moments before the murder occurred. The records also showed White and Whaley Jr. communicated with each other an hour before the murder and moments after the murder. According to phone mapping records, both White's and Whaley Jr.'s and third accomplice/co-defendant, Joseph Heyward III's cell phones were in close proximity of the murder during the time of the murder. After the murder, Whaley Jr was seen getting into Heyward's white Chevy Cavalier, which was also occupied by Heyward. Moments after, the defendant and co-defendants cell phones were hitting off of cell towers from the incident location until they reached their destination in North Charleston, SC.

That the above information is true and believable based on the investigation of Detective Alexander of the Charleston County Sheriff's Office who is able to prove the same against the form of the statute in such case made and provided for against the peace and dignity of the state.
