Hi Tony,

We had a productive steering committee meeting yesterday. I'm sorry you weren't able to join us and hope your trip to Aiken wasn't too soggy!

Following up on the meeting, I am writing to inquire about budget information that will be needed by the steering committee in order to finalize the package of recommendations and build a comprehensive narrative supporting those recommendations. I would like to meet with you and/or a member of your budgetary staff to discuss your FY14 budget, including any of the information below that you might be able to provide:

- The LGOA's various funding sources (How much money comes from each source? How much of the funding is state money?)
- A breakdown of funds by program area (How much money is allotted to the major different programs? In particular, information on HCBS is needed, including information on all funding sources.)
- Information on how many people are served and how many are on waiting lists
- Information on costs per person of the various major programs/services (or costs per service, depending on what cost utilization measures you use)

**Based on our meeting discussion yesterday, I would say the most urgent information needed relates to HCBS funded through the LGOA. So, if it is possible to get that information first, we could then follow up separately about the other information.**

Could you let me know who is best to follow up with regarding our request for the above information? Since you are a steering committee member, I've reached out directly to you, but I know your schedule requires a lot of travel so we'd be happy to follow up with a member of your budgetary staff, if that's best. We'd also be happy to meet in person to further discuss our request and what kind of information might be available.

Given the taskforce timeline, we hope to be able to follow up with you soon on this information.
