Thanks for passing this along.

Basically, I want to ask her about foster children who are placed in group homes in South Carolina. A lot of states have reduced their reliance on group homes for children because research shows that they do better with families. Some states have been hit with pretty large lawsuits over this issue. Meanwhile, [federal data shows](#) South Carolina puts its youngest foster children in group homes and institutions at a higher rate than any other state in the country.

So here are a few questions:

1. Does South Carolina need to transition away from this model?
2. If so, how would the state accomplish that?

I also want to talk about the OHAN unit and its responsibilities. Several advocates have told me that children in foster homes and group homes are being abused by each other and by staff members and the Department of Social Services is ill-equipped to handle these investigations.

1. Does OHAN, as some people have suggested, need to be a separate investigative unit from DSS?
