I walk with a cane & my husband does also. And yes this will help us too. It's not fair to Tina. I can't be holding onto Tina going outside downhill or we will both fall. Tina is a vital part of our family & should be able to participate in outdoor activities and at this time she is not able to. All because someone else feels like they think it's not in her best interest. We also requested a hot tub she has always loved hot tubs they relax her, help her C.P. I can't

understand why Tina is not being thought of here. I wrote a letter to Social Security & they refused our request. enclosed is a copy of the letter. AT the Group Home she lives at Dupont II they have purchased a large handi House had it furnished put an exercised Bike for physical therapy. Bought game systems we ect. she is like a 5 year old in mentality. she is not able to play these games they came close to spending 40,000 on this alone. The woman I wrote to at Social Security is Doctor Bassem & I wrote her on 7-3-14. I ~~think~~ we have been treated

unfair in this situation. we love our daughter very much & have her best interest in mind. I would also like to get a funeral or burial sit or a totem stone picked out for time before they spend all of her money. I hope you can help us with this matter. I do want Tina to be able to go outside & be able to be with us as a family. In the winter we have a five pit & sit around it & grill hot dogs & marshmallows. With the tub I can't get time in out of a regular tub. Thanks, for every thing you

My name is Betty Hunter I have a daughter named Tina Lynn Hunter she is handicapped she is deaf too C.P. has trisomy 13, has Sarcoidosis. She is like a 5 year old child in her mind. She is special to us, we love her very much. we kept her at home until she was 7 years old she could not walk. we sent her then to school at Spartanburg School for the Deaf and the Blind and the Multiple Handicapped. Our Family did not understand. No one can understand a mother's love for their child. But another mother. You do what you have to do for your child. We know IF we did not put Tina in school she would never become the best she could be, so we gave her the best gift we could ever give her the gift of life. A change at life. It was the hardest thing I ever did in my life. It broke my heart to see her go, I cried & cried but she came home ever weekend & every summer. When she turned 21 she could no longer go to school then so she came home to live with us full time. What I did not say Tina was in school 3 months & started walking on her own & started signing so she was talking with her hands. She stayed with us about a year & we could not handle Tina both myself & Tina's father is disabled. We are unable to care for her so we sought placement with Dupont II & TriDevelopment Center a Work Shop for the handicapped we wanted her to be happy but at the same time to

Tina because she is unable to go outside
 without a deck that will go outside onto
 the back yard it will go onto the back
 yard & will go onto the yard like I said our
 yard is slanted so it goes downhill very
 much & the deck will make it where she
 will be able to walk out onto the yard
 & it will be even with the yard & it
 will have rails so she can hold
 onto also it will benefit us also I'm
 not going to lie but we are mostly
 doing this for Tina, Crystal & Mr.
 It all should not have N. Love told
 us about using the money on the house
 for Tina, this is two times I've gotten
 approvals for things on the house because
 I was told to & now twice I've been
 told maybe & now now!. This is very
 upsetting if this fails I'm going to write
 the Governor I'm tired of this. Kim
 Young at Midland in Columbia is over
 Linas money is who Crystal ~~5 min~~ told me
 talk to she said she approved a walk in tub
 for Tina & now she is saying she is not
 going to even approve that. I feel she
 has a private vendetta against us that
 may sound silly but she has fought us tooth
 & nail. we have been working on it before last
 November. she doesn't even know what even is
 best for Tina, what she likes or what she needs
 so how can she say what is best for
 Tina, I also bought a bed & paid \$800. for it that
 she won't approve & flood flooring & paid for some

To put it down but she said that was before
time got her money but ~~that was before~~ ^{she said before it}
was before time got her money it would not pay
but it was put down for her. I told Crystal Smith
wasn't the money retractive so I didn't understand
why it would not pay. Like I said time
is special to us & we want her to have what
is needed to make her happy we have always
had a hot tub we have had 3 other hot tubs
& it would help with Tina's C.P. + Scurdosis with
C.P. she has problems with muscle spasms & with
Scurdosis breathing problems so the hot tub
will help with both of these we are also
asking for a screen room for privacy
for the hot tub & for time to be able to sit
outside in the summer like I would like to
point out we would be able to bring her some
more if we had things she enjoys & she didn't
get but trying to go outside & I could help
give her a bath & help with her personal needs
also with the back we were getting a handi-
capped Handicapped door opening into the
bathroom also rails in the bathroom all
this is for time. we want what is best for
time & to make her life complete. I don't want
for her to be happy & this is a way to help to
do that I really feel that in my heart & I feel
I have to fight for that I don't understand why Kim
Young can't see that I hope you can find it in your
heart to approve this for time. I think if time could
speak I'd say I want this. we appreciate your attention
to this matter & thank you very much.
