Gentlemen:

I am turning to you as my legislators for some help. Bill and I have known each other for years. Perhaps he can vouch for me to you, Mr. Lourie.

On September 16, 2007, I was hit head on while driving on North Pines Road in Blythewood because two kids were drag racing. Neither of the boys was injured, but I ended up having my right leg amputated below the knee.

The positive response from my family, friends and others in the community has been fantastic. The moral support given to my daughters and me, the meals fixed and delivered, the assistance in getting me to and from therapy and the money gifts have been so generous and graciously given as to be unbelievable. Frankly, I honestly don't know what I would have done without the donations I have received, since I now have no income. My employer paid me until the end of October, a real blessing. However, now, in addition to no paycheck, I pay \$724.06 monthly for my COBRA. You can imagine I am in what can only be called a "hardship" mode.

Both boys involved in the accident have been indicted for racing. The one who actually hit me had only minimum liability coverage and that \$25,000 has gone to my attorney, John Nichols, to be held in escrow. The second boy cannot be found and, since his name was not on the incident report, Allison Sullivan in Mr. Nichols' firm is trying to run down the insurance information on that driver. This looks to be a long-term mess.

The reason I am asking your assistance is that after months of trying to get any kind of public assistance, the only money I have received has been a check from SOVA... that I received only yesterday. I applied for food stamps before Thanksgiving. After a number of calls and another visit to DDS, I am still waiting for approval. I've been told I should know "something" by the end of this week. I have had no income since 10/31. If it wasn't for friends and family, I suppose I'd be dead in the street by now! I verify I have no income; I verify my expenses; and when they ask how I have been eating and meeting the COBRA payment and I say, "family and friends", it's as if there is no need for urgency.

I've applied for SSI and SSDI. I had a phone interview just yesterday (the second) for SSI because I had been honest when I applied and told them of the bank account my friends had set up while I was still in the hospital to raise money for the modification of my house, as well as other expenses. That account is now down to about \$50. I can't imagine that people will continue to put money in it.

After all, it's been four months since my accident. But it is true that I paid this month's COBRA only because St. John Neumann's Crisis Ministry gave me \$400 and a friend had a fundraiser for the additional money.

Does this sound fishy to Social Security? I don't know, but I cannot depend on the kindness and generosity of the community to keep me afloat. I see no reason why I shouldn't qualify for government assistance. I wonder about all those people they say defraud Social Security when I can't even get what I legitimately deserve.

Now Social Security needs to see the one, little life insurance policy I have. So I am still on hold.

Lastly, I have applied for Medicaid but have heard nothing as yet. I am desperate to get out from under that monthly \$724 COBRA payment. Of course, if I were approved for SSI, in addition to living expenses, I would receive Medicaid.

Is there anything you gentlemen can do to help me? I am at my wits' end. My kids cannot pay for me and my needs without ruining themselves financially. It is not right to expect friends to take me on as their favorite charity any longer. Why have I paid into Social Security and Medicaid all these years if I can't get them when I need them?

I apologize for the length of this letter. At least I haven't tried to tell you all this over the phone! I will be happy to give you even more details, however, if you want to give me a call at 788-4487. I certainly appreciate anything either or both of you can do to expedite any of these programs. Please let me hear from you.
