My husband John C Resmes went to serve his Country but instead he was given toxic drinking water, raped beaten, told if he would tell what happen that they were KKK members and that they would kill his two brothers, and his grandmother.

John was only 17 yrs old when he went into the marines, he did tell his CO but was told that he was making trouble, So he started going to sick call everytime he would run into the two marine it ended up being over 200 times. John started smoking weed, drinking, coming to role call late fussing with the CO that he told what happen to him things like that he was put out the marines in 1982.

John went to mental health hospital for 6 months behind this mess it didn't do him any good he started back getting into trouble, smoking crack this time his wife at that time was no help to him she didn't know what to do, so he found her in bed with his Uncle he went out and started breaking window out of about ten cars went to prison for 11 yrs 6 months and 15 days.

That is when I met him we talked for 3 yrs when he got out we were married John changed his name to YAHCHANAN that the man I know.

Yahchanan became a minister in my church for ten years and he was very good at what he did, Yahchanan helped me raise my children till

they were grown. I started to see changes in Yahchanan in 2009 he would start talking fast you couldn't understand him he started preaching on the street to all the young men telling them to love there family he stop preaching in the church, he started smoking, I took him to mental health in 2009 the late part of that is.

Yahchanan is a very good man, I am not saying this because he is my husband if you met him you would see for yourself, he never hit me or the children he was strict and set my house in order it was hard but we did it. Now he is in trouble he drinks a lot smokes cannabis a lot, he started going to the graveyard talking to his son that died of lung problem at seven days old, that is what that toxic drinking water do, it mess up your mind, Joint stomach, lung, you swell Yahchanan was beening treated for a lot of aches and pain that the water causes

Yahchanan started hearing voices, Yahchanan attempted suicide said he couldn't stop the voices in 1982, that's when he went to state hospital, this time Yahchanan has deep depression, Schizophrenia and he tryed to get a gun he said he can't take it any more.

On or about Dec 13 Yahchanan was stopped by two police officer that was already messing with him, Yahchanan called the house, and said they got me call the police, call the FBI Just shoot me in the head. I went to see what was going on at that time. They had him in handcuffs on the ground he was bleeding, the Police leg was bleeding

they told me to leave, I started to leave
and I saw Shante the police hit him with his
gun there charging him with attempted murder
We have been trying to get help for him in
2012 we wrote letter to the VA to try and get
his discharge upgraded so he could be put in a
VA hospital that is where he belong not in jail
he loved his country and wanted to serve his
country and would have stayed in the marines
for a longer period of time if it wasn't for
the rape. Can you please have some one look
into this matter for (John C Resmes) yatchanan
