SECTION 1: The Minutes for the meeting of September 15, 2005; copies of which had been previously mailed to each member of the Commission, were approved.

SECTION 2: On motion of Commissioner Harrell, seconded by Commissioner Carnell, the Commission unanimously passed a motion to advertise for a consulting firm to conduct a review of Department districts and supporting units, as shown in detail in the Appendix.

SECTION 3: The Commission unanimously passed a motion approving the sale of surplus right of way property, as shown in detail in the Appendix.

SECTION 4: The Commission unanimously passed a motion authorizing the Department to advertise, select and negotiate with a consultant engineering firm experienced in all phases of hazardous waste lead abatement for fiscal year 2006 bridge painting projects, as shown in detail in the Appendix.

SECTION 5: The Commission unanimously passed a motion approving the action of the Department in extending bituminous retreatment contracts to include additional resurfacing work, as shown in detail in the Appendix.

SECTION 6: The Commission unanimously passed a motion approving the action of the Department in extending existing construction contracts to include additional work, as shown in detail in the Appendix.

SECTION 7: The Commission unanimously passed a motion approving the action of the Department in removing roads from the State Highway Secondary System, as shown in detail in the Appendix.

SECTION 8: The Commission unanimously passed a motion approving the action of the Department in adding sections of roads to the State Highway System, as shown in detail in the Appendix.

SECTION 9: The Commission unanimously passed a motion approving the action of the Department concerning projects in the August 9 and September 13, 2005 highway lettings, as shown in detail in the Appendix.

SECTION 10: There were no committee meetings this month, therefore, no committee reports.

SECTION 11: On motion of Commissioner Harrell, seconded by Commissioner Hardee, the Commission unanimously passed a motion endorsing the completion of the safety improvements to Highway 17 south as a primary project. The Commission also noted that while safety improvements to Highway 64 were considered, funding is not available at this time. The Highway 64 project will be considered in the future when funding is available.

SECTION 12: On motion of Commissioner Turner, seconded by Commissioner Carnell, the Commission unanimously passed a motion to go into Executive Session.

EXECUTIVE SESSION

The Commission went into Executive Session for the purpose of discussing personnel and contractual matters. Commissioner Hardee excused himself from this discussion on the contractual matters.

Chairman Hooper reported that no action was taken in Executive Session.

Recommendations

Request for Consultant

The Department requests Commission approval to advertise for a consulting firm to conduct a review of Department District and supporting unites. By way of Act No. 181, 57-3-50, the General Assembly mandated a periodic review of highway districts and the territory embraced within the districts and make such changes as may be necessary for the proper and efficient operation of the district. This review will include all supporting units.

1. File 19.107B / US Route 25/378 / Edgefield County / Third District

During construction of improvements on Route 43 (now US Route 378), under Project No.268-A near the Town of Edgefield in Edgefield County, the Department acquired right of way for Route 43 (now US Route 378) by Deed to Right of Way from Callie Self Coker dated December 16, 1929.

During improvements at the intersection of US Route 25 and US Route 378, US Route 378 was realigned, creating approximately 800 feet of abandoned roadway. At the request of Countybank, Trustee of Trust "B" Created U/W of Callie Self Coker, a request was circulated to the engineering sections to determine if said parcel could be declared surplus. After review, it was determined that the parcel was surplus to Department needs. Therefore, a Gratis Quitclaim deed for approximately 1.50 acres of land to Countybank, Trustee of Trust " B" Created U/W of Callie Self Coker was executed on August 26, 2005.

2. File 26.100A / Grissom Parkway / Horry County / First District

During construction of improvements on Pine Island Road, under File 26.352 in Horry County, in the City of Myrtle Beach, the Department acquired right of way for Pine Island Road, by Right of Way Easement from Ramsey Company, Inc. dated April 24, 1957.

During negotiations to secure right of way needed for construction, the Department agreed to convey any surplus property between the adjacent owner and the new relocated road in exchange for the new right of way needed for Pine Island Road Relocation. Therefore, a Gratis Quitclaim Deed for approximately 0.22 of an acre of land to the City of Myrtle Beach was executed on September 1, 2005.

3. File 22.571 / US Route 521 / Georgetown County / First District

During construction of improvements on US Route 521, under File 22.571 in Georgetown County, near the Community of Kent, the Department acquired right of way for US Route 521, by Title to Real Estate from Kenneth W. Amidon dated June 2, 1997.

A request was received from the adjacent owner asking the Department to sell the remainder of a parcel of land. The request was circulated to the engineering sections to determine if said parcel could be declared surplus. After review, it was determined that the parcel was surplus to Department needs. Therefore, a Quitclaim Deed for approximately 0.404 of an acre of land to Dennis Cooper was executed on September 8, 2005, in consideration of \$16,000.00.

4. Roads in the City of Myrtle Beach / Horry County / First District

A request was received from the City of Myrtle Beach to convey by Quitclaim Deed the roads in the City of Myrtle Beach that were removed from the State Roadway System by Commission Removal on August 16, 2001, and March 24, 2005. Therefore, a Gratis Quitclaim Deed for a total of approximately 14.1 miles of roadway to the City of Myrtle Beach was executed on September 1, 2005.

5. File 40.526 / Lucius Road / Richland County / Second District

The Department received a request from the land surveyors for the Central Midlands Regional Transit Authority (CMRTA) asking the Department to assist in clearing title on property being purchased that fronts on Lucius Road. Because property pins exist within our 30-foot right of way, the Grantee has asked that a Quitclaim Deed be prepared stating that the Department has no interest in the property being purchased. The conveyance of this parcel does not affect the existing right of way or the roadbed in any way. Therefore, a Gratis Quitclaim Deed to Central Midlands Regional Transit Authority (CMRTA) was executed on March 14, 2005.

Professional Services Recommendations

October 20, 2005

The following sheets include recommendations for the Department to utilize professional consulting firms to provide various services, which may include design, right of way acquisitions, construction engineering and inspection, or other associated services. The Department requests approval from the Commission to advertise, select and negotiate for these necessary services.

Recommendations – October 20, 2005

REQUEST FOR CONSULTANT

The Department's Bridge Maintenance Office seeks approval to advertise, select, and negotiate with a consultant engineering firm experienced in all phases of hazardous waste lead abatement (containment, removal and disposal) for fiscal year 2006 bridge painting projects. These are required inspection services to assist the Department in complying with all applicable Environmental Protection Agency, South Carolina Department of Health and Environmental Control and OSHA regulations concerning removal and disposal of this hazardous material.

The Department does not have all the required training and certification necessary to perform this type work. Therefore, use of a consulting engineering firm is necessary.

EXTENSION OF BITUMINOUS RESURFACING CONTRACT

TO INCLUDE ADDITIONAL RESURFACING WORK

This extension was authorized by the Department prior to formal approval by the Commission since the adjacent work had reached such a stage of completion that the contractor involved could not accept the additional work unless it were authorized without delay.

Removal of Roads From State Highway Secondary System

The Department recommends Commission approval for the removal of certain sections of secondary roads from the State Highway Secondary System. These sections of roads may be removed for one of the following reasons:

1. Abandonment of Relocated Section of Highway
2. Deletions and Removal of Roads from State Secondary System - Roads may be deleted and removed from secondary system by exchanging for equal or less mileage or roads, which have a higher traffic importance. Ownership reverts to local government having jurisdiction (city or county). Approval of deletion or removal by local government is not required.
3. Abandonment of Right-of-way - Right-of-way may be abandoned if it is determined that the right-of-way is not required for right-of-way proposes or if the right-of-way is not needed for Department purposes.
4. Court Order
