I do not believe you realize how serious his medical condition is of which we have provided medical documentation and letters from his physicians to the court. I have copies of all faxed documents I have sent in via fax.

What exactly is there to move forward with He receives \$1040.00 of which he pays for medications and supplies for his medical care, doctors appointment and Aid care for someone to set with him because legally he cannot be by himself. His son receives \$222.00 and his daughter receives \$222.00.

I notified the court when the accident occurred and provided paper work of which they should have used to stopped the child support then because Jason L Drake

was in a medical induced coma, but no for the past year child support has just been adding up and adding up for the past year. Also other past support should have been reduced and/or stopped- but here again he was not aware of his rights to have the support lowered and/or stopped.

I am sorry the plaintiff has been allowed to get FI(family independence check) food stamps and Medicaid- but that is not Jason fault that she was allowed to leave of government assistance..

That is not Jason Drakes problem that the system has allowed her to make this a DSS case so she can get government benefit and continue to leave of them. It's called get a job.
