Lynn and I spoke at length this morning and have decided not to go forward with the pledge at this time for a number of reasons. We will continue to push hard for ethics reform but, at this point, without a solid contingent of organizations united behind a pledge, we do not think that the pledge will be successful, or useful. As a practical matter, with the holidays nearly upon us and session starting soon after that, we do not really have the time to effectively pursue a pledge.

Knowing that, as with so many other issues in Columbia, negotiations will continue, not boxing legislators into absolutes may be helpful in the end.

We look forward to continuing to work with your office, however, and will continue to push on legislators to do the right thing on ethics reform. Anne

It is my understanding that AARP doesn't wish to be involved in the pledge, although they will continue to support ethics reform in other ways, including a press conference that our groups are planning.

The LWV and CCL share a concern about not getting involved in the rapid evolution of the race for governor, although we think the basic idea of a pledge is a good one. We realize that at this point virtually everything is drawn into the vortex of the 2014 elections, but to preserve what distance we can, a pledge request would have to come from us, without public involvement from the Governor's Office before or after we send it out. Is that consistent with what you thinking of?

Dear All:

We are winding down the Ethics Reform State Tour this week with events in Rock Hill today and Myrtle Beach tomorrow. Our office very much appreciates your participation and continued support.

To continue the push for Ethics Reform, we would like to present a proposal for your consideration. At the Charleston Ethics Reform Event, Sen. Paul Thurmond challenged his fellow Senators to pass ethics reform quickly. He publicly stated that he would pledge his support to Governor Haley and ask his colleagues to vote for cloture (because there are as many as 100 amendments on the desk) and vote against adjourning debate (because amendments can receive up to 20 minutes of debate making for a very long night). Of course, we fully support Sen. Thurmond's challenge and would like to ask you if your coalition would be willing to develop a "pledge" that would have key points (including voting for cloture and against adjourning debate) to be sent to all Senators to encourage them to sign before session. The pledge could even be more simple and ask Senators and House members to sign a pledge to vote for a strong ethics reform bill - to include key proposals in H.3945 – before the end of this legislative session.

This is an idea that we are presenting to you for your consideration. We would like to continue to build the momentum up to the beginning of session and believe your involvement is most helpful for this type of pledge and reaching as many people as possible. Please let me know as soon as you can if you are interested this idea. I am happy to talk about it as well anytime. My cell is 803-665-0259.
