The regular monthly meeting of the Department of Transportation Commission was held at the headquarters building in Columbia, South Carolina at 12:45 p.m. In compliance with the Freedom of Information Act, the news media was advised in writing of the time, date and place of this meeting.

SECTION 1: The Minutes for the meeting of April 19, 2007; copies of which had been previously mailed to each member of the Commission, were approved.

SECTION 2: The Minutes for the workshop meeting of May 1-2, 2007; copies of which had been previously mailed to each member of the Commission, were approved.

SECTION 3: The Commission made public a report on the sale of surplus right of way property by the Department and shown in detail in the Appendix.

SECTION 4: The Commission unanimously passed a motion authorizing the Department to advertise, select and negotiate with consulting firms to provide, on an on-call basis, general engineering services, as shown in detail in the Appendix.

SECTION 5: The Commission unanimously passed a motion approving the action of the Department in extending existing bituminous contracts to include additional resurfacing work, as shown in detail in the Appendix.

SECTION 6: The Commission unanimously passed a motion approving the action of the Department in extending existing construction contracts to include additional work, as shown in detail in the Appendix.

SECTION 7: The Commission unanimously passed a motion approving the action of the Department in extending an existing pavement marking contract, as shown in detail in the Appendix.

SECTION 8: The Commission unanimously passed a motion approving the action of the Department related to roads in the State Highway Secondary System, as shown in detail in the Appendix.

SECTION 9: The Commission unanimously passed a motion approving the action of the Department concerning projects in the highway lettings of April 19th and April 17, 2007, as shown in detail in the Appendix.

SECTION 10: Commissioner Jones reported for the Invitations and Resolutions Committee and made a motion to approve the following resolutions:

- Thomas Spratt Memorial Bridge – York County
- John Tye Heath Hill Interchange – Dorchester County 751
- John W. Land, III Highway – Clarendon County 765
- Arie Black Guess Highway – Barnwell County 753
- Annie Mae Kinsey Highway – Jacksonboro to Walterboro 754
- Representative Jewell P. McLaurin, Jr., Highway – Dillon County 755
- Guy "Snow" Prater Highway – Laurens County 756

The motion was seconded by Commissioner Stevenson and passed unanimously by the Commission. Copies of the resolutions are shown in detail in the Appendix.

SECTION 11: Commissioner Carnell reported for the Legislative Committee. The committee discussed the Congressional visit to Washington scheduled for June 26-28 and received a status report on pending legislation including the Senate restructuring bill. The committee also received a briefing on a bill related to dyed fuel and tax rebates. No action was taken and no motions were made.

SECTION 12: Commissioner Atkins reported for the Enhancements Committee. The committee discussed the actions taken in the workshop meeting. No other action was taken and no motions were made.

SECTION 13: Commissioner Stevenson reported for the Mass Transit Committee. The Mass Transit staff presented the mass transit proposed allocation plan to local transit providers and transit partners across the state for FY 2007-2008 to the Committee for approval. Commissioner Stevenson made a motion for full Commission approval of the Mass Transit FY 2007-2008 funding allocation plan, as shown in detail in the Appendix. The Commission unanimously approved the motion.

SECTION 14: Chairman Hooper reported for the Finance Committee. The committee was given an update on the DOT finances and reviewed the budget. No action was taken on the budget. On motion of Chairman Hooper, seconded by Commissioner Atkins, the Commission unanimously passed a motion that the State Highway Engineer be given the authority to approve the STIP amendment based on the information and comments received to date. This approval will not take place until after the comment period expires on May 22, 2007 and all comments have been evaluated. Should the Department receive any comments, it will notify the Commissioners and the items will be taken up at the June Commission meeting.

SECTION 15: Chairman Hooper reported for the Audits Committee. The committee received an updated status of the current audits and also discussed the manpower situation in the audits division. An audit plan for internal/external projected audits was also presented for approval. Chairman Hooper made a motion to approve the plan as submitted. Commissioner Atkins seconded and the Commission unanimously approved. A copy of the audit plan is shown in detail in the Appendix.

SECTION 16: There being no further business to come before the Commission, the meeting was adjourned at 2:10 p.m.

Surplus Property Public Notice

May 17, 2007

In accordance with the State of South Carolina Statue 57-5-340, by this publication the Department is making public the Surplus Property Real Estate Transactions to the State Highway Commission. The following sheets include a breakdown of surplus property real estate transactions. These transactions may have resulted from negotiations with property owners during right of way acquisition, direct sales, settlement of a condemnation action, and/or corrective actions to previously reported sales.

1. File 10.432A / US Route 17 / Charleston County / First District

During construction of improvements on Road S-563 (Hanover Street) and Road S-119 (Nassau Street) under File 10.500 in the City of Charleston in Charleston County, the Department acquired right of way for Road S-563 and Road S-119 by Letter of Dedication from the City of Charleston dated July 19, 1961.

The construction of US Route 17 and the Arthur Ravenel Bridge under File 10.432A resulted in a portion of Road S-563 and Road S-119 becoming dead end streets. However, research revealed that these portions of roads came from the City of Charleston, so the determination was made to return these portions of roads to the City so that they could abandon them and return them to the adjoining landowners. The request was circulated to the engineering sections to determine if said parcels could be declared surplus. After review, it was determined that the parcels were surplus to the Department's needs. Therefore, a gratis Quitclaim Deed for a total of approximately 0.21 of an acre of land to the City of Charleston was executed on April 3, 2007.

2. File 23.471A / Road S-189 / Greenville County / Fourth District

During construction of improvements on Road S-189, under File 23.441 in the City of Greenville in Greenville County, the Department acquired a sight triangle for Road S-189 at the intersection with SC Route 291 by Right of Way Easement from Sarah Elizabeth Humphreys dated February 28, 1959.

A request was received from CC3, LLC, the adjacent landowner, asking the Department to relinquish a portion of the present 50 x 50 foot triangular area referenced above. The request was circulated to the engineering sections to determine if said parcel could be surplus. After review, it was determined that a portion of the sight triangle could be relinquished to the adjacent landowner in exchange for fee simple title to the remaining 25 x 25 foot triangular area. Therefore, a gratis Quitclaim Deed for approximately 0.02 of an area of land to CC3, LLC was executed on April 3, 2007.

3. File 23.239A / SC Route 183 / Greenville County / Fourth District

During construction of improvements on SC Route 183 Western Corridor, under File 23.239A in the City of Greenville in Greenville County, the Department acquired right of way for SC Route 183 from Tom S. Bruce, Sr., N. A. Waldrop, III, and Tamma W. Carson by Title to Real Estate dated October 7, 1998.

During acquisition of right of way on SC Route 183 Western Corridor, under File 23.239A an agreement was made during negotiations to convey a parcel located between SC Route 183 Western Corridor and abandoned Pinkney Street in exchange for new right of way needed for the project. Therefore, a gratis Quitclaim Deed for approximately 0.10 of an acre of land to Holmes Bible College, Inc. was executed on April 19, 2007.

4. File 30.519 / Road S-61 / Laurens County / Third District

During construction of improvements on Road S-61, in the City of Laurens in Laurens County, the Department acquired right of way for Road S-61 by the Construction Act.

The adjacent property owner to both sides of Old Chestnut Street requested that the road be conveyed to him. The request was circulated to the engineering sections and old Chestnut Street was declared surplus to SCDOT's needs. According to SCDOT policy, the road should be relinquished to the City of Laurens since the road came into the System under the Construction Act. The City of Laurens has agreed to accept the property and plans to retain it to allow the railroad access to its property. Therefore, a gratis Quitclaim Deed for approximately 0.15 of an acre of land to the City of Laurens was executed on April 24, 2007.

Professional Services Recommendations

May 17, 2007

The following sheets include recommendations for the Department to utilize professional consulting firms to provide various services, which may include design, right of way acquisitions, construction engineering and inspection, or other associated services. The Department requests approval from the Commission to advertise, select and negotiate for these necessary services.

REQUEST FOR CONSULTANTS TO PERFORM "ON-CALL" GENERAL
ENGINEERING SERVICES

The Department requests Commission approval to advertise, select and negotiate with consulting firms to provide, on an on-call basis, general engineering services. Requested services include but are not limited to: surveys, subsurface utility engineering, hydrology/hydraulics, roadway design, bridge design, utility coordination, geotechnical engineering, and traffic engineering studies and related other duties deemed necessary.

The purpose of on-call consultants is to provide additional engineering services when the Department staff is not able to perform the required to meet established project schedules. The Department anticipates the selection of eight (8) consulting firms for on-call services through a Quality Based Selection process. For each project (i.e. each particular scope of services), the Department and the consulting firm will independently prepare cost estimates in order to facilitate negotiation of the associated fees.

The on-call agreement will cover an approximate three (3) year period renewable annually beginning with the date of execution. The services will be used for both state and federal projects.

EXTENSION OF BITUMINOUS RESURFACING CONTRACTS

TO INCLUDE ADDITIONAL RESURFACING WORK

It is recommended that the Commission approve the action of the Department in extending existing bituminous contracts to include additional resurfacing work as follows:

GREENVILLE & SPARTANBURG COUNTIES:

(Commissioner F. Hugh Atkins)

Contract of F & R Asphalt, Inc. – File Nos. 23.290610 & 42.290610 – extended to include full depth patching (File No. 23.290610) on S-587 and S-532 (Greenville), and SC 150 (Spartanburg).

Estimated Cost of Extension \$ 227,434.00

Funding for this extension will come from underruns on other roads in this contract and the rebate for additional contract time.

YORK COUNTY:

(Commissioner Bobby T. Jones)

Contract of Rea Contracting, LLC – File No. 46.170710 – extended to include resurfacing (File No. 46.170710) on S-680, S-688 and S-1555.

Estimated Cost of Extension \$ 57,782.23

The York County Transportation Committee is funding this extension.

These extensions were authorized by the Department prior to formal approval by the Commission since the adjacent work had reached such a stage of completion that the contractors involved could not accept the additional work unless it were authorized without delay.

EXTENSION OF CONSTRUCTION CONTRACTS

It is recommended that the Commission approve the action of the Department in extending existing construction contracts to include additional work as follows:

CALHOUN COUNTY: (Commissioner Marvin Stevenson)

Contract of Rea Contracting, LLC – File No. 9.36613 – extended to include drainage improvements (File No. 38.112C) on S-63 in St. Matthews.

Estimated Cost of Extension \$ 37,209.50

The Calhoun County Transportation Committee has allocated funding for this extension.

DARLINGTON COUNTY: (Commissioner Bobby T. Jones)

Contract of C. R. Jackson, Inc. – File No. 16.157B – extended to include intersection improvements (File No. 16.127B) on US 15 and S-135 in Hartsville.

Estimated Cost of Extension \$ 94,416.75

HORRY COUNTY: (Commissioner Joe Young)

Contract of Palmetto Paving Corporation – File No. 26.145C – extended to include resurfacing (File No. 26.145C) on S-147, S-410, S-739, and S-740 in the City of Loris.

Estimated Cost of Extension \$ 88,742.57

The Horry County Transportation Committee has allocated funding for this extension.

These extensions were authorized by the Department prior to formal approval by the Commission since the adjacent work had reached such a stage of completion that the contractors involved could not accept the additional work unless it were authorized without delay.

Recommendations: May 2007

EXTENSION OF PAVEMENT MARKING CONTRACTS

It is recommended that the Commission approve the action of the Department in extending existing pavement marking contract work as follows:

SPARTANBURG COUNTY: (Commissioner F. Hugh Atkins)

Contract of Traffic Markings, Inc. – File No. 42.200602 – extended to include pavement markings (File No. 42.200602) on S-43, US 176 and S-187.

Estimated Cost of Extension \$ 87,243.40

Funding will be provided by various underruns of the contract.

This extension was authorized by the Department prior to formal approval by the Commission since the adjacent work had reached such a stage of completion that the contractors involved could not accept the additional work unless it were authorized without delay.

Removal of Roads From State Highway Secondary System

The Department recommends Commission approval for the removal of certain sections of secondary roads from the State Highway Secondary System. These sections of roads may be removed for one of the following reasons:

1. Abandonment of Relocated Section of Highway
2. Deletions and Removal of Roads from State Secondary System - Roads may be deleted and removed from secondary system by exchanging for equal or less mileage or roads, which have a higher traffic importance. Ownership reverts to local government having jurisdiction (city or county). Approval of deletion or removal by local government is not required.
3. Abandonment of Right-of-way - Right-of-way may be abandoned if it is determined that the right-of-way is not required for right-of-way proposes or if the right-of-way is not needed for Department purposes.
4. Court Order

Correction of Description of State Highways

The Department recommends Commission approval of the correction of the description of sections of State Highway previously added to the State Highway System. The description of roads currently in the State Highway Secondary System may be changed for relocation purposes, to revise the description of the termini to show what was actually constructed by contract, county line changes, or a change in the secondary road number.

Additions to State Highway Secondary System

The Department recommends Commission approval to add sections of road to the State Highway Secondary System for construction and maintenance. The Department may add roads to the State Highway Secondary System by request of the County Transportation Committees contingent on mileage being available under the current mileage cap. Roads may be added to the State Secondary System by the construction of a new roadway, accepting existing county/city roads into our Secondary System by the swap method, or by county line changes. Roads added to the State Highway System must be constructed to Department standards or reviewed for compliance with Department standards.

Rescind Action Adding Roads to State Highway Secondary System

The Department recommends the Commission rescind its previous actions adding roads to the State Highway Secondary System for construction and maintenance. The Department may rescind action on roads, which have not been constructed and formally accepted into the State Highway Secondary System. Roads may be rescinded due to right-of-way being unavailable, problems arising during construction, or funding issues.

Transfer of Road between Secondary and Primary Systems

The Department recommends Commission approval to transfer sections of road from the Secondary System to the Primary System, or vice versa. Pursuant to the provisions of Section 57-5-50 of the Code-of-Laws of South Carolina, 1976, the Commission may transfer any route or section of route from the state highway secondary system to the state highway primary system, or vice versa, when, in its judgment, such transfer is advisable to better serve the traveling public.





This bridge was named after my grandfather, Colonel Thomas B. Spratt. This event took place over sixty years ago and some members of the York County Delegation may not recall this event. As his name sake I think is it appropriate to refresh those memories.

In 1938 my grandfather ran for State Treasurer of South Carolina on the Democratic ticket. Unfortunately he died of pneumonia in the middle of the campaign. The York County Delegation saw fit at that time to name the existing bridge the **Thomas B. Spratt Memorial Bridge** as a tribute to him because of the respect and high regard in which he was held, not only in York Country but throughout the entire State. A memorial ceremony was held for that occasion and in 1976 the bridge was rededicated with the erection of a granite monument on the Rock Hill side of the river.

It would be appropriate that the name of the current bridge, **Thomas B. Spratt Memorial Bridge**, remain on any new bridge in that vicinity. This would preserve the memory of one of York Country's most respected citizens, a direct descendent of the first settlers in the county in the mid 1750's, a World War I veteran highly praised for his part in the planning for the 118th Infantry Regiment, 30th Division's breach of the Hindenburg Line and the beginning of the defeat of the German Armies, as well as a prominent banker held in high regard throughout the State

While the proposed new bridge is in its earliest stages of discussion, we wanted to make sure the Delegation is aware of our interest and concern at the start of the planning of this proposed project.

Spratt Memorial Bridge**, is perpetuated we strongly recommend that the Delegation take that action now so that keeping the present name is made a matter of record to cover any future project concerning any subsequent relocation or renaming of this bridge.





\$42.99 Million**












