- the costs of housing these children,
- the health of the children upon arrival,
- the federal government's ultimate plan for the children,
- the failure of federal officials to notify mayors/governors when large groups of UACs are transported to their states, and
- the message the U.S. is sending to other countries with regard to an "open border" policy.
