50 State Survey of Dementia Training Requirements

Justice in Aging, in collaboration with the Alzheimer's Association, released a new survey of dementia training requirements in each state. The number of Alzheimer's and other dementia diagnoses is on the rise, but there is often little to no training for staff and professionals that work with these populations. This survey revealed gaping holes in state law and offers promising practices to inform improvements and changes for the future. The findings from the survey are available in a five-paper series.

The Centers for Medicare & Medicaid Services (CMS), the Assistant Secretary for Planning and Evaluation (ASPE), and Mathematica Policy Research are hosting a webinar on their development of quality measures for Medicaid fee-for-service beneficiaries using home and community based services (HCBS). The webinar will include topics about refining the measures definitions to more directly reflect the HCBS care experience, developing risk-adjustment models to produce more equitable state-level or program-level comparison, establishing approaches for addressing small sample sizes, and identifying strategies for benchmarking and displaying results.
