Governor Nikki Haley News:

The State: Politicians, activists, victims celebrate Emma's Law at State House

More than 100 people gathered in the State House downstairs lobby Wednesday to celebrate the passage and signing of Emma's Law, the first bill the Legislature has passed in years targeting drunk drivers.

Note: Gov. Nikki Haley, who signed the bill several weeks ago, performed a ceremonial signing and gave two pens she used to David and Karen Longstreet, the parents of 6-year-old Emma Longstreet of Lexington, who was killed by a drunk driver in 2012 on her way to church.

Note: Haley gave a third pen to LaToya Jenkins, the mother of 3-year-old Josiah Jenkins, who was killed earlier this year in a car crash caused by a man police say was a repeat drunk driver.

South Carolina's unemployment agency announced Wednesday that it made a \$60 million early payment toward its debt to the federal government, helping to reduce businesses' insurance taxes.

Note: Gov. Nikki Haley also attributed the early payment to a better economy, saying it's "exactly what is possible when a state sees the kind of economic growth and success that we have." The state's unemployment rate fell to 5.5 percent in March.

As more people in South Carolina find jobs, the S.C. Department of Employment and Workforce is whittling down the debt it took on during widespread unemployment in the worst recession in a lifetime.

Note: "With our unemployment rate at a six year low and more people working than ever before, it's clear we are moving in the right direction and today's announcement is further proof that it's paying off for the people of our state," Haley said.

The state Budget and Control Board voted Wednesday to give \$6 million to SC State University, on the condition that the school give the Governor's Office and legislators more of a controlling hand in its finances.

Note: Haley defended her plan to have accountants and consultants work with the college's administration to correct problems. "You can all this a Band Aid or not, this is the matter of fact of are they going to get their accreditation," Haley shot back. "We won't be able to recover if they lose their accreditation... and we are asking for accountability in return."

South Carolina's only public historically black college received an emergency loan of \$6 million Wednesday with conditions that the state have more control over the school's spending and work with the college to attain better management.

Note: Haley said that more than 80 percent of the loan is to pay outstanding bills for basic maintenance and food service on campus. "These are essential services. This is food, this is maintenance. The thing we can do is get them moving again," Haley said.

Note: With dozens of S.C. State trustees, administrators and supporters filling the budget board meeting room Wednesday, Haley said she wanted to help the school repair its finances while working with accreditors, who placed a warning on the university. "We can't leave the school alone to figure this out," she said. "We have to be part of the solution."
