Legislative Update- Week Of 01/19/2016-01/21/2016

Here are the highlights from the first week of 2016 legislative session in the Senate –

ROADS AND BRIDGES – There were several discussions last week among senators about roads and bridges. I expect the Finance Committee to vet various ideas on Tuesday with the full Senate to begin debate on Wednesday.

STATE OF THE STATE ADDRESS – Governor Nikki Haley delivered her 6th State of the State Address last Wednesday night. At one point during the speech, Governor Haley asked senators to stand if they support requiring legislators to disclose the sources of their private income and independent investigations of ethics complaints. Those who have read my updates over the past couple years know I have been very involved in trying to push those ethics reforms, so I was happy to stand in response to the Governor's question.

STATE TAX REFUNDS – Last week the SC Department of Revenue announced a new fraud prevention effort that will delay processing of early tax returns. For returns filed before March 1, DOR expects to issue refunds by the end of March.

STATE OF SCDOT – Last week the SCDOT released its State of SCDOT report for 2016. You can read the report [here](#).

PUBLIC HEARING ON WIDENING OF BELVEDERE–CLEARWATER ROAD – SCDOT plans to widen Belvedere-Clearwater Road in Aiken County from Old Sudlow Lake Road to U.S. 1. As part of that process, SCDOT will hold a public hearing on the proposals on Thursday, January 28, 5:00-7:00 p.m., at Lakeside Baptist Church in Clearwater. 5:00-6:00 will be an informal viewing of plans. 6:00-7:00 SCDOT will explain the project and accept public comments/questions.
