I felt the need to contact you once more because of the serious nature of this attempted murder of my brother I don't know who's arranging these hits on my brother but it has to stop there is no way for an inmate on lockup to gain access to 2 butcher knives and conceal them when he is supposed to be search before allowed to enter shower and door should be locked before cuffs are removed I'm asking for your help to look into this matter and refer in to any other level of government that can and will hold these officers accountable also including letter from my brother and the one sent to warden Reynolds.

Statement

April 8, 2016

On the 6th of April, while working on lock up (RHU) an incident happened between myself (Jerome McFadden) and another inmate by the name of Osha Johnson, who was there and current to this statement on lock up.

While I was taking up trays after the morning meal, inmate Johnson started throwing urine on me. This was observed by Sgt. Johnson, and Sgt. McDaniels. Shortly after this happened Sgt. Loyd and Sgt. Patton took inmate Johnson to the shower. Upon this inmate return to his room, he told these officers that someone throw faces in his room.

He was taken back to the shower by these 2 Sgts., where he remained until lunch was being served by myself, inmate Jones and officer Moore. Both Sgt. Loyd and Patton excused themselves from the task. While I was passing out drinks, an inmate by the name of [REDACTED] ([REDACTED]) told me that the shower that inmate Johnson was in was unlocked.

And that he had 2 knives waiting for me to come by. I left the area and informed officer Mrs. McFadden on what had been told to me by inmate Wright.

Inmate OSha Johnson came out of the unlocked shower and started running around with the knives looking for me. Associate Warden Davis, Major Jefferson and a host of others were called to the scene. Eventually, inmate Johnson surrendered and was placed in a lock-up holding cell. No one said anything to me about it nor questioned me concerning it.

The next day I told Associate Warden Sharp that I no longer felt comfortable working on lock-up as a result of the incident and the fact that the inmate's door had been left open by these officers.

I believe upon the information provided to me, and the fact that both Loyd and Dutton had not been present, that it was not a mistake that this inmate's door had been left open. And for these reasons I must take some measure to insure my safety. And so I start with this statement.

Hello Warden Reynolds

I receive a letter from my brother Jerome McFadden he has indicated there has been yet another attempt on his life this time by an inmate on lockup by the name of Osha Johnson who was escorted to the shower by Sgt. Lloyd and Sgt. Dotton they left inmate Osha Johnson unguarded and in an unlock shower and just happen to be armed with 2 butcher knives knowing Jerome McFadden would be along any moment to serve lunch to the inmates when inmate Johnson realized Jerome was not coming around the corner he ran out of the shower screaming swinging the knives while yelling where's Jerome at, someone is still trying to kill my brother and your officers are arrainging it to look like it was an inmate on inmate crime I trust you will look into who supplied this inmate with such large knives that are impossible to conceal why did these two officers leave an inmate unattended and unsecured who instructed them to arrange this hit on Jerome and why, had Jerome not been warned not to go around that corner he could possibly been killed this is unacceptable behavior on these officers to help commit murder Jerome has never been a trouble maker always a happy person raised by good God fearing parents the DNA test he took came back inconclusive that means he is innocent of the crime he is incarcerated for but the powers to be are blind to truth some have orders to hinder Jerome in every way from his court papers being held up or never making it to the courts even denying him the right to be heard by the supreme court to unjust persecution to strip him of his


privileges and women guards trying to have sex with him and probably would yell rape after the fact and some have gotten angry and caused trouble for Jerome.

Jerome McFadden 136919 ask me to notify you that he sent a writ of injunction about the way he has been treated at Lee Correctional institution they are putting him around the most violent people he is surrounded by hostility from inmates and the guards he is fearful of bodily harm and they took the money that he had in his account could not send the letter certified he wants your help in this matter it is illegal to tamper with or obstruct US mail and or place an inmate in harms way Jerome has never been a trouble maker or a violent person its not in his nature and there will be some people in control of him that want to make it look like he is they have an agenda to cover up the wrong that has been done to Jerome, Joseph McCulloch, Jr. did a DNA test which he said came back inconclusive in 2006 that's impossible they should have released Jerome since August 2006 but it shows their determination to keep him in prison forever, he is asking to be moved back to Florence county jail until his name can be cleared we appreciate your assistance in this matter.
