(McClellanville, SC) Family Court granted custody of a 7-year old girl to her father. Today, the child's maternal grandmother, 67-year old Emma Irene Young, picked her up from school and drove away. Deputies located Young in Georgetown County. With the assistance of Georgetown County Sheriff's Office, the child was recovered and returned to her father. Young was arrested for custodial interference and lodged at the Sheriff Al Cannon Detention Center. Her Bond Hearing is set for tomorrow at 10 am.
