Dear Judge Duffy et al.,

We had a good discussion with Defendants on Tuesday but are somewhat skeptical that the parties can complete this process without input from the Monitors and Mediator.

Attached is the current version of the Settlement Agreement with all known issues.

We still have not received any proposed “phase in”, but Defendants have indicated that they would get that to us today. After we have a chance to see what, if anything, in the proposal affects the Settlement Agreement, we will respond about what is agreeable as soon as possible.

We would like to schedule a meeting, or at least a call, for all remaining issues next Thursday, March 24 between 10:30 am and 5 pm, which are the last day and times this month the Monitors are available to

meet together with the parties.

We all need to finalize the Settlement Agreement now, for the system and for the children.
