Palmetto Business: Aiken, Union counties become South Carolina Work Ready Communities

South Carolina's Aiken and Union counties recently became the 43rd and 44th counties in the Palmetto State to be certified as South Carolina Work Ready Communities (SCWRC). This certification is awarded to communities that have met workforce and education goals set forth in the initiative, which is available in all 50 states. To date, South Carolina boasts the most certified communities in the nation.

Note: "With Aiken and Union counties being named Certified Work Ready, we are only two counties away from reaching our goal of being the first state in the country to be fully certified," South Carolina Gov. Nikki Haley said. "This is a testament of Team South Carolina's hard work in making sure we have the most competitive business environment in the world for companies looking for a place to call home."

Rep. Jenny Horne gave a tearful farewell speech Thursday morning as she prepares for her last days in the S.C. House of Representatives. Horne, R-Summerville, thanked former state Treasurer Thomas Ravenel for her foray into politics. When Ravenel was suspended in 2007, after being indicted on cocaine charges, District 94 Rep. Converse Chellis was appointed to the post. Horne and three other Republicans ran for the seat in a special election primary to finish Chellis' term, sending her and Heyword Huston to a runoff. She credits her congratulatory call to Huston with giving her the drive to try again.

A gun law reform senator from Charleston is setting himself up to potentially filibuster a bill that would allow Georgia residents with concealed weapons permits to carry their weapons in South Carolina. Democratic Sen. Marlon Kimpson has drafted 80 amendments he hopes will show senators why the bill is bad legislation. After about 20 minutes of discussion and a short break Thursday, the Senate adjourned without voting on any of the amendments. "With three more days in the session, time is in my favor," Kimpson said. "They have the votes (to pass the bill). What I am trying to do is educate the body so they will make the right decision."

The South Carolina House is attempting to tackle the issue of regulating outside organizations' spending on political campaign materials, which the Senate has yet to formally debate this year. House members Thursday amended a bill that requires elected officials to report income from private companies so that it also requires nonprofit organizations to reveal the source of their money that is spent on elections. "It's been debated long and hard up here," said author and Laurens Republican Rep. Mike Pitts. "This amendment requires third

parties who get involved in elections to do the same thing that you and I are required to do. We are required to report what money comes to us. We are required to report where the money goes.”

Lawmakers want to ban the most successful – and controversial – nonprofit in the state’s private school-choice program along with other private groups that work to raise money for the \$12 million-a-year program. State budget writers have agreed to ban the Palmetto Kids First Scholarship Program and three other nonprofits from raising money to help students with disabilities pay private-school tuition. Those donations qualify for a state tax credit.

Federal Judge Richard Gergel has moved the date of a court hearing for accused race killer Dylann Roof forward one day, to June 7, in Charleston. Gergel gave no reason for the change. The hearing at 2 p.m. on June 7 will be the first for Roof since federal prosecutors announced Tuesday afternoon they will seek the death penalty.

The bar meeting will be at 2 p.m. June 7 in Judge Richard Gergel’s downtown courtroom, according to a filing Thursday. It had been set for that morning. The judge could set a date for Roof’s death penalty trial. With a trial in state court planned for Jan. 17, it’s still unclear which government will try Roof first.

Aiken Standard: Editorial: South Carolina road bill lacks sustainability

South Carolina lawmakers patted each other on the back following passage of S. 1258, a Senate road funding bill that legislators say will increase funding by more than \$4 billion in the next 10 years. Indeed, the Senate bill provides a funding boost and restructures the S.C. Department of Transportation and State Infrastructure Bank. It also amplifies funding, lawmakers say, by making it easier to secure a series of short-term loans to expedite road projects as opposed to floating larger, long-term general obligation bonds. But it's also not entirely accurate to suggest S. 1258 won't potentially impact the general fund and the agencies that would be dependent on it.

North Carolina legislators are lining up concessions necessary for the redrawn boundary between North Carolina and South Carolina to take effect in 2017 after more than 20 years of work. The Senate voted unanimously Thursday to confirm the re-established 334-mile boundary separating the states and alleviate problems for about two dozen homes and businesses shifting states. The bill addresses public schools, taxes, sewer districts and an alcohol beverage permit for a South Carolina convenience store that will wind up in North Carolina.

The U.S. government will release its forecast Friday for how many hurricanes and tropical storms are expected to form over Atlantic and Caribbean waters in the next six months. It's an annual reminder from the National Oceanic and Atmospheric Administration that coastal living comes with significant risks. The Atlantic hurricane season officially starts June 1, but tropical weather got a head-start this year: Hurricane Alex made an unseasonable debut in January over the far eastern Atlantic, and the National Hurricane Center says an area of low pressure between Bermuda and the Bahamas could be brewing into something bigger Friday or Saturday. Note: The 2015 season was slightly below average with 11 named storms, including two tropical storms that made landfall and caused flooding in South Carolina and Texas. Hurricane Joaquin, one of two storms to reach major hurricane strength, killed all 33 mariners aboard a cargo ship that sank off the Bahamas in October.

Building on a week of public outcry over racial inequality in the public school system, the NAACP Charleston branch kicked off a campaign to file federal civil rights complaints against the Charleston County School District on Thursday. Addressing about 50 people in the church fellowship hall, local education advocate Jon Butzon suggested filing complaints with the U.S. Department of Education and the Office for Civil Rights about issues including racial disparities in school disciplinary actions and performance on Advanced Placement tests. According to school district data, black students are six times more likely to be suspended than their white counterparts.

Russell and his group were among 19 people who escaped the flooded Hidden River Cave on Thursday afternoon. They navigated neck-deep water, rushing currents and mud so thick it sucked off the police chief's

boot. It was pitch black. "It was shooting waterfalls out of the ceiling. The walls were thundering, there was so much water moving through it," said David Foster, the executive director of the American Cave Museum at Horse Cave and a guide for 30 years, who rushed into the darkness to help with the rescue. "You just don't know what Mother Nature is capable of. There's only so much cave, and there's way more water." The group that spent more than six hours inside the cave included Clemson University students, four tour guides and two police officers who got trapped when they tried to rescue the group, Kentucky State Police Trooper B.J. Eaton said.

Obama at Hiroshima: 'Death fell from the sky'

Barack Obama on Friday paid tribute to the "silent cry" of the 140,000 people killed by the world's first atomic bomb attack and sought to renew attention in his unfulfilled vision of a world without nuclear weapons, as he became the first sitting U.S. president to visit Hiroshima. "Death fell from the sky and the world was changed," Obama said, after laying a wreath, closing his eyes and briefly bowing his head before an arched monument in Hiroshima's Peace Memorial Park that honors those killed on Aug. 6, 1945, when U.S. forces dropped the bomb that ushered in the nuclear age. The bombing, Obama said, "demonstrated that mankind possessed the means to destroy itself."

Since her use of a private email server was made public last year, Democratic presidential candidate Hillary Clinton has insisted she turned over all work-related emails to the State Department to be released to the public. But after 14 months of public scrutiny and the release of tens of thousands of emails, an agency watchdog's discovery of at least three previously undisclosed emails has renewed concerns that Clinton was not completely forthcoming when she turned over a trove of 55,000 pages of emails. And the revelation has spawned fresh criticism from presumptive Republican presidential nominee Donald Trump.
