⑨ Any one arrested? No! No Police report! all N/A.

Pizza. After I got in the House they locked the Doors and Started Touching me and calling me Names. They jirbed off my clothes and Stole my \$30.00 from my Bra. ⑬ Who's Fault was the Accident? The So Said Home owner Charles R Tweicas, the other Man Friend and the (14) year old girl from GA that hangs out with them. The three of them invite Girls and women in their house and Have Wild Sex with them. They receive Food Stamps as none of the three work, They Sell the Food stamps for Drugs & Beers. They charge other people Money to hold Parties in their House. These (3) People Now Stop me at the Bus Stop, at the Bus Station, they do not ask me for a Dollar like some smart elcs, they just Grab me, stick their hand in my Bra and Fish a round till they Find my change from my Grand Father. I report to the

-- SO -- Yesterday 5 Sept 2012 while I was shopping for Food in the Seneca SC WalMart, These three came up behind me, Stuck Her Hand in my Bra and Stole my \$30.00 food money again!! I Made Loud Noises, They Took my Money and ran, I called the Police and Told them what happen. — — — These three people are Dangerous and I am always afraid of them attacking me, raping me, Stealing my money and calling me names. — — — They scam other people too, these three are Dangerous for Seneca and the Community they Live in, the Neighbors Children are in Danger. The House they Live in is a Cess Pit and is dangerous to all people of Oconee County. They are for sure a constant Dange to my freedom, good thinking, and Well Being. I Donna M Cobb believe that These three should Be Jailed and charged, Their House Condemned, and removed from the Ground, there are too many Sins coming from that House. I Donna M. Cobb Love to Be in Seneca, ride the Free Cat Bus and Shop for my Self as much as possible with my own Money from My Grandfather, But, Until these <sup>three</sup> ~~men~~ are apprehended, I will remain worried and Frightened. — —

I am writing in response to your letter of September 6, 2012, regarding your granddaughter's recent experience with the DHHS Casualty questionnaire form. The Casualty questionnaire is generated by the computer system when one of our Medicaid beneficiaries receives medical treatment for trauma. The Casualty questionnaire is used to gather information about the event that caused harm to our beneficiary. Your letter of September 6<sup>th</sup> has provided all of the information that we need. Ms. Cobb's Medicaid eligibility is not in jeopardy due to this form.

I apologize that you felt that the DHHS employees were not helpful. As an agency, we try to assist our customers as much as possible. If you would like to discuss the staff response further, please call the DHHS Regional Administrator in your area, Stan Brown, at (864) 260-4541.
