

DEAR MRS. HALEY

I Ed Ray Tyner Jr. am writing you on behalf of GINA MARIE MOORE and my son Brettley Ray Tyner. On Sept. 5th my son was born at McLeods Medical Center in Florence. After waiting 10 days on my son to get out of the NICU, because he was 3 weeks premature, A DSS worker, Kelly Gilbert shows up at my mother's, Bobbie T. Small in Darlington, informing my mother to call us and Kelly tells us a trace of marijuana and methadone was found in Brettley, 6 points over cut off level. Kelly tells us if GINA does not sign safety plan that she will go to jail and could my 71 year old mother and 73 year old step-father take a drug test and pick my son up from the hospital and take care of Brettley.

Sept 15th GINA and I go to Hartsville and GINA signs the safety plan and Kelly Gilbert informs me I have no rights to my son. I left out furious and GINA was ordered to take a drug test. I'm 50 years old, works hard, law abiding, honest, have helped other people raise their kids and I can't have what I waited for all my life. I have no rights but I take care of my family and everybody else's. I've done for anyone who needed help and I can't help my son cause of DSS that's not right Mrs. Haley in fact that is wrong and your system is wrong. GINA goes to jail and I get her out with money meant for our family. DSS has been jerking me around, had to get a family court lawyer, Mrs Haywood, a ex DSS worker turned lawyer and the DSS jerked her around and she is a nice lady but that was more money wasted, trying to get results and my son.

AFTER 60 days WE CALL DSS, BECAUSE INVESTIGATION
STAGE IS UP, WE WANT TO KNOW WHO OUR NEXT CASE-
WORKER WAS AND NOBODY KNOWS NOTHING. NOV. 21ST
A MRS. FOULKS COMES TO MY MOTHER'S AND TELLS MY
MOTHER, GINA AND I HAVE TO DEC 5TH TO ENROLL IN RUBICON.
NOW MY MOTHER THINKS I'M A DRUG ADDICT AND THE LADY,
MRS. FOULKS DID NOT TALK TO US. DEC. 18TH MRS. WYNN
COMES TO OUR HOME FOR THE FIRST TIME WE SEE SOMEONE.
SHE SAYS SHE IS A NEW WORKER, DOES NOT KNOW WHAT
HAPPENED TO MRS. FOULKS AND SHE CAN'T ANSWER NO
QUESTIONS BUT SHE ASKS A LOT LIKE, PHONE NUMBER, HOW
LONG WE HAVE BEEN HERE, OUR JOBS, EVERYTHING THAT
SHOULD HAVE BEEN DONE 2 MONTHS EARLIER OR AT LEAST
BY KELLY GILBERT. THE DSS PEOPLE HAVE NOT BEEN
STRAIGHT UP, NOR DOING ANYTHING IN HELPING US GET
MY SON HOME. THEY ARE SNEAKY, CAN'T BE HONEST AND
HAVE SET US UP TO LOOSE OUR SON NOT GET HIM HOME.
NOT BEING RACIST BUT THESE BLACK LADIES ACT LIKE
THEY OWN ME AND I DON'T KNOW WHAT IS GOING ON. THEY
WON'T DRUG TEST ME, THEY SAY GINA IS THE ONE INDICTED
AND I KNOW THEY ARE LAZY AND CAN'T TRUST THEM.
INSTEAD OF THE DSS SETTING PEOPLE UP TO LOOSE THEIR
FAMILY, HOW ABOUT GETTING SOME HONEST, HARD WORKING
PEOPLE THAT WILL HELP GET THEIR CHILDREN BACK. NOT
A SUPERVISOR LIKE MRS. MCDANIELS TELLING YOU THAT IF
YOU DON'T GO TO RUBICON SHE WOULD GET A FAMILY COURT
JUDGE THAT WOULD PROBABLY RULE IN THE DSS FAVOR.
SHE DOES NOT KNOW US AND THEY HAD GINA GOING
TO A METHADONE CLINIC. NO ONE HAD SAID THAT, GINA
GOES TO A REGULAR DR. AND DOES NOT TAKE BUT 20 MGS
A DAY. WE HAVE NEVER BEEN TO A CLINIC BUT MRS. MCDANIELS
HAD FALSE INFORMATION FROM SOMEONE BESIDES US.

DR. ANU CHAUDRY TOLD GINA IN FEBRUARY WHEN SHE FIRST FOUND OUT SHE WAS PREGNANT THAT IF SHE QUIT TAKING THE METHADONE SHE COULD MISCARRY MY SON AND I WAS THERE WHEN IT WAS SAID. DR. CHAUDRY KNEW GINA WAS GETTING METHADONE FROM A REAL DR. AND SHE KNEW SHE WAS NOT TAKING BUT 20 mgs. (2) 10 mgs TABLETS A DAY. THE PEOPLE GIVING THAT FALSE INFORMATION WAS MCLEODS DURING THE DELIVERY. THE TRACE OF POT WAS WRONG, WE KNOW GINA SHOULD NOT HAVE BEEN AROUND ANYONE SMOKING BUT THE POINT IS SHE WAS NOT SMOKING AND I DON'T SMOKE, BUT THESE 93 DAYS OF SLEEPLESS NIGHTS, ALL THE PAIN OF MY FRIENDS ASKING ~~WHY~~ WHY DON'T YOU HAVE YOUR SON, THE THOUGHT OF LOSING MY SON OVER A TRACE OF POT. SOMETHING IS NOT RIGHT AND FOR MY BEAUTIFUL, HEALTHY SON TO BE WITHOUT HIS PARENTS IS VERY WRONG. MRS. HALEY I NEED SOMEONE TO HELP US, THAT WON'T TELL US WRONG AND WILL STAND BEHIND US. WE ARE GOOD PEOPLE I WOULD NOT WASTE YOUR TIME BUT EVERYTHING I SAY IS TRUE AND I NEED SOMEONE TO POINT US IN THE RIGHT DIRECTION. GIVE ME SOME RIGHTS, FIX THIS DSS SYSTEM WHERE DECENT PEOPLE DON'T HAVE TO GO THROUGH THE MISERY LIKE US. PLEASE WRITE US BACK OUR FAMILY DEPENDS ON IT. I HOPE YOU AND YOUR FAMILY HAS A MERRY CHRISTMAS I KNOW MY SON WON'T BE SAFE AND TAKING BETTER CARE OF TO HE FINALLY GETS HOME TO HIS FAMILY.
