Hello Ladies!

Ebony Perkins, with help from Jamesha Shackerford and others on the CCCF team, successfully submitted two grant applications – one to Pfizer for \$50,000 and one to Dominion for \$25,000. Whoo Hoo!

And, a number of generous South Carolinians made donations to the fund including \$1,000 from Charles and Janet King of Winnsboro and \$15,000 from Richard and Ursula Smith of Columbia.

To-date, the Grants Committee has awarded \$1,940,930.40 to VOADs that are helping to rebuild 976 homes. Note: The VOADs have provided \$16,827,500.00 in financial and in-kind donations.

\$4,055.58 – balance in the fund as of 7/12/16

A recap of funds raised since July, 2016 (the beginning of the Foundation's fiscal year) follows:

\$38,612.07 – raised 7/1/16 – 9/22/16

**\$41,460.00** – raised 10/4/16 – 10/14/16

**\$25,000.00** – AT&T (not collected)

**\$25,000.00** – Dominion (not collected)

**\$50,000.00** – Pfizer (not collected)

\$184,127.65 - One SC Available Unrestricted Funds (through 1/14/16)

\$402,500.00 – sponsorship dollars collected from 17 of the 26 committed companies\*

\*As the sponsorship monies were requested to support rebuilding projects following the 2015 floods, those dollars can only be used for this purpose. I suggest we ask the sponsors if they will allow rebuilding projects to be extended into the new counties affected by Matthew's floods.

Please note that the Governor's request for donations has resulted in **\$141,460** raised since October 4<sup>th</sup>.
