Hi,
Thanks for your patience.

We recommend just two for veto:

- 1- Proviso 33.33 as you mentioned. This is a lead in to Medicaid expansion, and the Administration and General Assembly have spoken against that.
- 2- Line (5) (a) of Proviso 118.17 – Nursing Home Rate Increase of \$5 million.

Provisos that we have no opinion on:

Though the Exec. Budget also called for deleting Provisos 33.2 and 33.27, we have no opinion about them, veto-wise. In fact, with you work with DMH, you may not want to veto 33.27

Provisos to leave in please:

Also, even though you or us may have previously recommended deleting certain provisos, let's please leave them in now, including:

Proviso 33.16 (LTC Facility Reimbursement Rates)
Proviso 33.18 (Nursing Services to High Need Kids)
Proviso 33.20 (Cost and Quality Effectiveness)
Proviso 33.29 (Medicaid Reporting)

We have reasons we need these in the budget still. We've made agreements, etc. So we need them in please.

Thanks.

Another thing to note:

Do not delete DHEC's 34.14 – we need that language that the Senate voted 3/5 on.
