Mr. Poore called the meeting to order and Councilman David L. Hooper gave the invocation.

Mr. Hooper called the clerk's attention to a typographical error on page two of the February 16, 1982 minutes. On the motion of Mr. Hooper, seconded by Mr. Bratcher, Council voted unanimously to approve the minutes of the February 16, 1982 and February 19, 1982 meetings as corrected.

Mr. Poore stated that he would like to go on record as stating that County Council cannot pass an ordinance to conflict with Home Rule or either a state law.

Mr. David Watson presented Ordinance #78 (REAPPORTIONMENT) for third and final reading. On the motion of Mr. Hooper, seconded by Mr. Rhodes, Council voted four in favor and one against the adoption of Ordinance #78. Mr. Wright voted against the ordinance.

Mr. Watson presented Ordinance #80 (COUNTY CODE) for third and final reading. On the motion of Mr. Kinley, seconded by Mr. Hooper, Council voted three to two. Mr. Wright and Mr. Bratcher abstained on the issue. Ordinance passed by majority vote. (See attached)

Mr. Blakley discussed bulk rate mailing. He suggested using this method whenever possible to save money.

On the motion of Mr. Hooper, Council voted unanimously to adjourn at 9:20 a.m.
