We are pleased to inform you that Jacqueline Johnson has been approved for our Partner's for Healthy Children program retroactive to December 1, 2008. Therefore, she will continue to receive Medicaid without any break in coverage. If you have outstanding bills for your daughter since that date, please ask her providers to submit those claims to Medicaid for payment.
