MAY 8, 2006
MINUTES**

PRESENT: Chairman Gunnells, Vice Chairman Simpson, Councilman Davis, Councilman Calhoun, Councilman O'Quinn and Councilman Norris.

CALL TO ORDER:

Chairman Gunnells called the meeting to order at 7:30 p.m.

PLEDGE OF ALLEGIANCE:

Chairman Gunnells led the Pledge of Allegiance.

INVOCATION:

Councilman Norris gave the invocation.

FREEDOM OF INFORMATION ACT:

Chairman Gunnells stated for the record that both the Press and Banner and the Index Journal were notified of the meeting and that the meeting was posted on County Buildings as required by the Freedom of Information Act.

APPROVAL OF MINUTES:

Councilman Davis made a motion to approve the minutes of the April 24, 2006, regular county council meeting. Vice Chairman Simpson seconded the motion. The motion carried 6-0-0.

Vice Chairman Simpson made a motion to approve the minutes of the May 1, 2006, budget workshop. Councilman Davis seconded the motion. The motion carried 5-0-1 with Councilman O'Quinn abstaining.

OLD BUSINESS:

- a) Third reading of an ordinance (06-06) to adopt new, updated Abbeville County Personnel Policies and to rescind all prior ordinances or resolutions that may be in conflict. Councilman Davis made a motion to approve third reading. Councilman O'Quinn seconded the motion. The motion carried 6-0-0.
- b) Third reading of an ordinance (06-07) to amend the Abbeville County Official Zoning Map for a 2.18 acre tract of land located at Big Mouth Cove and identified by tax map number 054-00-00-087 from Forest/Agricultural (FA) to Restricted Residential (R-8). Vice Chairman Simpson made a motion to approve third reading. Councilman Norris seconded the motion. The motion carried 6-0-0.

- a) First Readings: New Policy – All first readings are read into the record by the Chairman, and a vote is not necessary.
 - 1) An ordinance (06-08) to amend the Abbeville County Official Zoning Map for a 1.87 acre tract of land located at 5910 Hwy. 72 West and identified by tax map number 154-00-00-030 from Forest/Agricultural (FA) to General Commercial (GC).
- b) Resolutions:
 - 1) A resolution (06-30) authorizing the County Director to purchase software and hardware from Smith Data to finalize the updates for Family Court. Councilman Norris made a motion to approve the resolution. Councilman Davis seconded the motion. The motion carried 6-0-0.

County Director Scott Moulder informed Council that CPW has been requested to extend and upgrade water lines into Donalds/Due West Water Authority Territory and Abbeville County Council's support has been requested. Councilman Norris then made a motion for the County Director to issue a letter of support to CPW. Vice Chairman Simpson seconded the motion. The motion carried 6-0-0.

Chairman Gunnells reconvened the meeting following executive session and announced that no action was needed following executive session.


ADJOURNMENT:
