- Survivors affected by October 1-23 storms and flooding need to register by today, January 4, for federal disaster assistance.
- All survivors receive letters from FEMA explaining the status of their application. Should they require information or clarification, they can call the FEMA helpline at **800-621-3362** or **TTY 800-462-7585** c those who use **711/VRS** may call **800-621-3362**.

Other Federal Agencies

U.S. Department of Agriculture

- The U.S. Secretary of Agriculture’s disaster declaration makes all qualified farm operators in the 29 designated and 13 contiguous counties eligible for low-interest emergency loans from the U.S. Department of Agriculture’s Farm Service Agency.

Small Business Administration (SBA)

- The U.S. Small Business Administration’s Economic Injury Disaster Loan program is available to eligible farm-related and nonfarm-related entities that suffered financial losses. With the exception of aquaculture enterprises, SBA cannot provide disaster loans to agricultural producers, farmers or ranchers. - There are four Business Recovery Centers open to assist homeowners and businesses in applying for low interest disaster loans.
