Top state and federal leaders say South Carolina's new inland port near Greer is not only good for the economy, it's good for the environment and is saving wear and tear on the state's infrastructure. Gov. Nikki Haley and U.S. Sen. Lindsey Graham visited the inland port Friday along with congressmen Jeff Duncan and Trey Gowdy. Wick Moorman, the president and CEO of Norfolk Southern, arrived with officials from the South Carolina Ports Authority on a vintage train with a locomotive and passenger cars dating to the mid-20th century.

**Anderson Independent:** Baldor Electric expanding Anderson County

Baldor Electric Co., a manufacturer of energy-efficient industrial electric motors and mechanical power transmission products, is expanding its Anderson County facility. South Carolina Republicans will keep their traditional role as being the first southern voters to choose their party's presidential nominee. The 168-member Republican National Committee voted today to set South Carolina's primary for February 2016, the state GOP announced. Under the party's new rules, only South Carolina, Iowa, New Hampshire and Nevada will hold contests in February 2016.

Republican leaders overwhelmingly voted Friday to shorten their presidential selection process in an attempt to minimize damage from GOP candidates attacking each other. "This is a historic day for our party," RNC chairman Reince Preibus declared. Iowa and New Hampshire will retain their coveted spots atop the presidential primary calendar, and South Carolina and Nevada also secured top spots, as they have in the past, as part of a larger plan that could significantly reshape the 2016 presidential election.

Former Charleston Sen. Robert Ford faces more allegations that he used campaign donations for personal expenses and misrepresented his spending. The Senate Ethics Committee issued a complaint Thursday after finding probable cause that the 65-year-old Charleston Democrat improperly used campaign money after he resigned last year as a hearing was going on that publicly detailed similar allegations over four years, which included adult-store purchases.

The state's Supreme Court justices on Thursday appeared skeptical of Myrtle Beach property owners' plans to sue AVX Corp. over groundwater pollution that is near – but hasn't directly impacted – their land, although a lawyer representing those owners said it is too early in the legal process to dismiss their claims. Surfside

Beach lawyer Gene Connell told the justices that Circuit Court Judge Benjamin Culbertson improperly dismissed the claims because he refused to hear evidence that the owners' property values have decreased and that bank loans have been denied due to the nearby pollution.
