Morgan Olson, a company that outfits and customizes step-in vans for companies such as FedEx, gave S.C. Gov. Nikki Haley a tour this morning as the plant officially opened in North Charleston. The company announced in August it was coming to the Palmetto Commerce Park to be near the Mercedes-Benz Sprinter vans assembly plant, bringing a \$1 million investment and about 120 jobs.

She made the promise she often does for company's bringing jobs to South Carolina that she would work to solve any problems the company had, including fighting to keep out unions.

Congratulations, you are a member of South Carolina's "unorganized militia." Now that you know that, state Sen. Tom Corbin, R-Greenville, wants to make sure you have access to guns in case the governor ever calls on you to defend the state. Corbin has proposed a new state law — unanimously approved Wednesday by a Senate subcommittee — that would guarantee all members of the unorganized militia "shall have the right, at his own expense, to acquire, possess, keep, and bear all firearms that could be legally acquired or possessed by a citizen of South Carolina as of December 31, 2012."

A Senate panel advanced a bill designed to ensure that South Carolinians can hold on to their weapons regardless of what Congress does. A 3-0 vote Wednesday sent the bill to full committee. On the surface, the measure tweaks an obscure state law regarding the state's "unorganized militia" - to which all "able-bodied" South Carolinians over age 17 belong.

A state Senate panel today unanimously cleared a bill that would allow South Carolinians to keep legally-acquired firearms and ammunition regardless of any gun-control steps the U.S. Congress might take. The bill by Sen. Tom Corbin, R-Travelers Rest, provides for the firearms for the state's "unorganized militia," which is mentioned in a section of state law dating back to 1881 that deals with the composition of the state militia. Corbin proposes that any able-bodied citizen over 17 years old who can legally purchase a firearm be included in the unorganized militia.

South Carolina public schools continue to fall short of goals that were set to ensure that by 2020 they will be adequately preparing our children to be successful in the increasingly competitive global economy. It's time to put it to a vote, Summerville. As Bo Petersen reported, Town Council wants to know if it's legal to pay Mayor Bill Collins \$50,000 a year in addition to his mayor's salary of \$15,000 for work he's done as acting town administrator.
