effectively than I can - since I will automatically make sure that he is in the loop. While Joel does pick up a good deal of the inbound questions, I wanted to make sure that everyone knew he was your first point of contact on that front.

It is important to emphasize, for those of you who do not know, if we are going to read about it in the press the next day - the agency **MUST** contact us to keep us in the loop. Remember, there is a probability that Joel is the next call after your Public Information Officer and we should **ALL** be on the same page.

As has happened in the past, Joel and I will also be tied into the hurricane response team and most other situations, as well.
