I have a check from Jerry Richardson for \$300,000. Can someone swing by the office to pick it up?

Also, wanted to clarify – Joann told me on Friday that total giving since the press conference has been appx. \$123,000. I looked at the online donations link today, and it had total credit card donations at \$13,545. Couple of questions – 1) Is that credit card donation total since the inception of the fund, or since it was named One SC, and 2) I know you all received one check for \$100,000. I'm assuming the \$10,000 or so difference (between the

\$123,000 and \$100,000 check plus credit card donations) is checks you have received?

We are working on planning a fundraising event. I will keep you in the loop.
