Meeting discussion points:

- ✱ Footnote the report to explain the differences between the Original Appropriations and the Adjusted Appropriations – in total, by year
- ✱ For FY02 and FY03, state that DMV was a Division within the Department of Public Safety and was comprised of Vehicle Services, Driver Services, and Field Services. Note that Administration, Administrative Hearings, MCS, and Contributions were all in accounts that were included in other divisions within DPS. However, when DMV became a stand-alone Agency, these offices, along with the expenses, were

transferred to DMV.

- ✱ For FY04, 05, and 06, just explain the differences in total. Marcia wants us to explain the reduction of State Funds and how the budget was not adjusted, explain the pay plan adjustments, the conversion of temps to perms, etc.
- ✱ Also, note the \$8.5 million of Capital Projects shown in the FY06 Adjusted Appropriation line.
