To Whom It May Concern:

My husband, Norman King (SSN 248-29-3480), has Alzheimer's disease and Parkinson's disease. His primary care physician is Dr. Traesa Brown, 805 Pamplico Hwy., Suite B-230, Florence, SC 29505, phone, 843-679-4019. My husband is in the latter stages of this disease. He is a fall risk and is quickly losing his ability to walk, eat, and communicate verbally. In fact, last night, I had to call EMS twice to get him off the floor, as he fell out of his bed, and I could not physically pull him up.

I am having great difficulty dealing with the physical changes that come with these diseases. He is at home most days, although he goes to Adult Day Care 3 days per week, 6 hours per day. I need help. I do not know whether home help or a nursing home would be the best recourse. This, as I understand it, would be the decision of the nurse who would visit our home and assess him.

I also understand that the usual wait time for a decision on our application is from 6 to 8 weeks. I really need help before that time. If there is any way that this application could be expedited, I would appreciate it, as his condition is deteriorating very quickly. I do not know how long I can continue to care for him in the home. Physically, I am not well, as I have rheumatoid arthritis.

I thank you for any help you may afford me in this matter.
