- Registration deadline: **Dec. 4, 2015.**

Key Points

- South Carolina survivors can call FEMA's helpline: 800-621-3362 or TTY: 800-462-7585. (Multilingual operators available)
- The registration deadline is a week and a half away.
- Survivors should register only once. If they have questions after registering, they can call the helpline or visit a disaster recovery center to get help.
- All disaster recovery centers are closed on Nov. 26, Thanksgiving Day.
- Beginning Monday, Nov.30, DRC hours will change to 9 a.m. to 6 p.m. Monday through Friday and 10 a.m. to 3 p.m. Saturday.
- Survivors with ongoing housing needs should stay in touch with FEMA by calling the helpline.
- *Only if asked:*
 - Homeowners do not apply to FEMA for acquisition of their property. The state administers the program for voluntary property acquisition to mitigate future hazards.

By the Numbers (as of COB 11/24/15)

- **Registrations**
 - **89,897** individuals and households have contacted FEMA for assistance or information.
- **Assistance**
 - Individuals and Households:
 - § More than **\$67.1 million** approved to help survivors in their recovery.
 - More than **\$58.4 million** of that amount approved for housing assistance such as temporary rentals and essential home repairs.
 - More than **\$8.7 million** approved for Other Needs Assistance such as medical, dental and other serious disaster-related needs.
