Dear Mr. Keck:

This correspondence is written to request continuation of funding for the South Carolina Department of Mental Health (SCDMH) Telepsychiatry Consultation Program.

This innovative underserved medical services intervention program, unparalleled in the nation, was initiated in the spring of 2008 with significant financial assistance from The Duke Endowment and the South Carolina Department of Health and Human Services (SCDHHS) as essential partners. The original program concept was to provide timely psychiatric assessments utilizing modern high-speed electronic video and voice equipment to reduce the cyclical overload of behavioral health patients waiting for such assessments in any South Carolina emergency department (ED). Through the continued financial commitments of both The Duke Endowment and SCDHHS, the program has not only achieved, but also maintained, that program expectation.

To date, the program provides direct assessments in 18 hospitals and will be adding additional hospitals in the next 45-60 days. As of January 23, 2014, program psychiatrists have surpassed 18,000 assessments with the effect of reducing hospital length of stay by one-half.

Dr. Meera Narasimhan, Professor and Chairman in the Department of Neuropsychiatry and Behavioral Sciences at the University of South Carolina School of Medicine, and her team have analyzed preliminary data using a propensity score analysis through a grant awarded by the National Institute of Mental Health. Her team has demonstrated that this unique program has improved access, increased affordability, and provided quality care to the citizens of the State of South Carolina with mental illnesses. The results demonstrate:

MISSION STATEMENT

To support the recovery of people with mental illnesses.



1. Length of ED visit: Length of the initial ED visit was reduced for the patients seen in the Telepsychiatry Program as compared with controls (0.43 days versus 1.35 days);
2. Inpatient admission following ED visit: The Telepsychiatry group had half the number of inpatient admissions (11% vs. 22%) as matched controls;
3. 30-day follow-up with a mental/substance abuse professional: The Telepsychiatry group had significantly higher rates of 30-day follow-up than the matched sample (46% vs. 16%);
4. 30-day inpatient costs after the intervention were significantly lower in the Telepsychiatry than the control group (\$8,290 vs. \$11,224 at 30 days).


The above-referenced outcomes clearly demonstrate the success of this unique public, private and academic model of healthcare delivery.

SCDMH projects that continued financial support from both The Duke Endowment and SCDHHS will form the foundation of sustainable growth for the Telepsychiatry Consultation Program into the future. SCDMH has developed a plan of sustainability built on contributions from all of the relevant parties: The Duke Endowment, SCDHHS, the South Carolina General Assembly, SCDMH, and modest user fees by which participating hospitals also contribute to the financial stability of the Program.

In summary, SCDMH respectfully requests consideration of a FY2014 SCDHHS grant of \$1 million to enable the Department to provide this necessary program to additional hospitals. It also respectfully requests consideration of future commitments from SCDHHS in FY2015 and FY2016 each of \$1 million. The demonstrated savings from this Program to the mental health continuum in South Carolina far outweighs these modest requests. SCDMH would be happy to prove these contentions, many of which are highlighted in the results cited in items 1-4 above.


Thank you for consideration of this multi-year request. As always, the South Carolina Department of Mental Health appreciates the partnership of the South Carolina Department of Health and Human Services in meeting its mission of providing effective mental health treatment to the citizens of South Carolina.
