

Dear Mr. Keck:

This letter is to inform you that the Centers for Medicare & Medicaid Services (CMS) is approving the South Carolina submission of Managed Care Organization (MCO) contract amendments between South Carolina Department of Health and Human Services and following entities:

- Amendment 1 – Unison Health Plan of South Carolina, Inc.
- Amendment 1 – Select Health of South Carolina, Inc.
- Amendment 1 – BlueChoice Health Plan of South Carolina, Inc.
- Amendment 2 – Absolute Total Care, Inc.

These amendments adjust the individual risk scores for each MCO. The adjusted capitation rates are effective October 1, 2010 – April 1, 2011. The risk adjustment was calculated and certified by Milliman, Inc. We accept the rate methodology for calculating the individual risk scores.

If any future actuarial study or financial review reveals inaccuracies in the submitted risk adjusted rate data, we reserve the right to recover the federal share of any unallowable costs resulting from the inaccuracies. In addition, if errors in the rates are later determined, you will be required to adjust your quarterly expenditure report to the Centers for Medicare and Medicaid Services.

One last one -

White proposed a new proviso that state health agencies push harder to require co-pays, and use means testing to get recipients to put more skin in the name. He said some health agencies do this, some do not. Ott challenged him, wondering what authority and guidelines agencies would use to slap co-pays on folks. White said he just wants to be sure agencies are maximizing cost sharing, especially agencies using state-only funds. He said he understands that DHHS may not have co-pay wiggle room.

The proviso was adopted.

That was it for tonight. Cooper did say that Keck will be presenting in room 108, at 8:30.

Tony, looking ahead ... next week the Ways and Means budget gets printed. Then by law it sits a week for House members to read. Then that third week we'll have full House debate. Onward to Senate from there.
