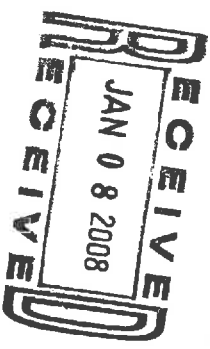

Thank you for bringing your concern regarding the suspension of your home care worker, Ms. Angela Lumpkin, to our attention. We have looked into the matter and learned that Ms. Lumpkin's enrollment as an attendant has been reinstated and she meets the requirements to provide services. However, due to a recent change in fiscal intermediaries, we will need to have new forms completed for payroll purposes.

We understand that Ms. Nicki Matthews visited you both on Friday, February 1, 2008, and was able to complete the necessary forms. As soon as they are received and verified by the fiscal intermediary, we anticipate that Ms. Lumpkin can begin providing attendant services to your husband again.
