SCDC's Chief of Psychiatry, Dr. Beverly Wood, along with our Chief Psychologist, Dr. Reuben Ridgeway, have evaluated death row safekeeper Jonathan Binney (Taylor Cross) for his alleged Gender Dysphoria. After her evaluation, Dr. Wood has diagnosed him as having Gender Dysphoria per the diagnostic criteria of the Diagnostic and Statistical Manual of Mental Disorders, Fifth Edition (DSM-5). This is a confirmation of the diagnostic assessment provided by Dr. Brown.
